NEW! Regulatory Amendments to the Apprenticeship and Certification System

The following regulatory amendments will be coming into force on October 30, 2024.

<u>Overview</u>

- 1. The apprentice to journeyperson ratio is now 1:1 for all skilled trades programs, except for the trade of Esthetician
- 2. Manitoba's Voluntary Trade Regulations have transitioned to Apprenticeship and Certification Board By-Laws; and

Includes Apprenticeship Manitoba's first ever Designated Occupations:

- Baker
- Powerline Technician
- 3. Program Standards Updates have been made to the following trades:
 - Bricklayer
 - Cook
 - Lather (Interior Systems Mechanic)
 - Roofer
 - Sloped Roofer
 - Esthetician
 - Hairstylist
- 4. The following two voluntary trades programs are no longer designated under the Interprovincial Red Seal qualifications, and have therefore been de-designated in Manitoba:
 - Electric Motor Systems Technician
 - Rig Technician

APPRENTICE TO JOURNEYPERSON RATIO

Apprentice to journeyperson ratio's will be changing to 1:1, **effective October 30, 2024.** This applies to all Manitoba designated trades programs, except Esthetician.

Apprenticeship agreements with a 2:1 apprentice to journeyperson ratio, registered *before* October 30, 2024, are authorized to continue with a 2:1 ratio

Apprenticeship agreements registered <u>on or after</u> October 30, 2024, will follow to a 1:1 apprenticeship to journeyperson ratio.

- Employers who are unable to meet the 1:1 ratio requirement may be eligible for a ratio adjustment that allows them to use a 2:1 ratio for a limited time based on demonstrated need.
- In voluntary trades only, employers may employ a Designated Trainer in lieu of a journeyperson to supervise and train an apprentice.

Apprentices in the final level of their training program will continue to be exempt from required apprentice-to-journeyperson ratios. *Applicable for trades programs comprised of three levels or more*.

PROGRAM STANDARDS UPDATES

As part of the Red Seal National Harmonization Initiative, the following program standards updates have been made:

Bricklayer

- Former: The apprentice must complete **1,600 hours** of technical training and practical experience.
- Current: The apprentice must complete **1,800 hours** of technical training and practical experience.

<u>Cook</u>

 Former: Two levels, with each level consisting of a period of at least 18 months during which the apprentice must complete 2,700 hours of technical training and practical experience; with

A regulated minimum wage rate of:

- (a) 120% of the provincial minimum wage during the first level; and
- (b) 145% of the provincial minimum wage during the second level.
- Current: Three levels, with each level consisting of a period of at least 12 months during which the apprentice must complete 1,800 hours of technical training and practical experience; with

A regulated minimum wage rate of:

- (a) 120% of the provincial minimum wage during the first level;
- (b) 135% of the provincial minimum wage during the second level; and
- (c) 150% of the provincial minimum wage during the third level.

Lather (Interior Systems Mechanic)

- Former: Four levels with each level consisting of a period of at least 12 months during which the apprentice must complete 1,800 hours of technical training and practical experience.
- Current: Three levels with each level consisting of a period of at least 12 months during which the apprentice must complete 1,800 hours of technical training and practical experience.

Roofer:

- Former: Three levels, with each level consisting of a period of at least 12 months during which the apprentice must complete **1,400 hours** of technical training and practical experience.
- Current: Three levels, with each level consisting of a period of at least 12 months during which the apprentice must complete **1,800 hours** of technical training and practical experience.

Sloped Roofer:

- Former: Two levels, with each level consisting of a period of at least 12 months during which the apprentice must complete **1,400 hours** of technical training and practical experience.
- Current: Two levels, with each level consisting of a period of at least 12 months during which the apprentice must complete **1,800 hours** of technical training and practical experience.

The trades of Esthetician and Hairstylist are designated compulsory trades programs in Manitoba. The following program standards updates have been made to their respective trade regulations.

Esthetician

Nail Technician:

- Former: "nail technician" means a person who performs the following tasks to the standard indicated in the provincial occupational analysis for the subcomponent trade of nail technician:
 - (a) manicures and pedicures;
 - (b) natural and artificial nail repairs;
 - (c) nail decorations;
 - (d) artificial nail applications.

- Current: "nail technician" means a person who performs the following tasks to the standard indicated in the provincial occupational analysis for the subcomponent trade of nail technician:
 - (a) Performs manicures and pedicures;
 - (b) Performs artificial nail applications;
 - (c) Repairs natural and artificial nails.

Skin Care Technician:

- Former: **"skin care technician"** means a person who performs the following tasks to the standard indicated in the provincial occupational analysis for the subcomponent trade of skin care technician:
 - (a) skin care treatments;
 - (b) specialized facial treatments;
 - (c) body treatments;
 - (d) make-up artistry;
 - (e) hair removal;
 - (f) correction of skin problems using currents;
 - (g) lash and brow tints.
- Current: "skin care technician" means a person who performs the following tasks to the standard indicated in the provincial occupational analysis for the subcomponent trade of skin care technician:
 - (a) Performs body treatments;
 - (b) Performs skin treatments;
 - (c) Performs advanced facial treatments;
 - (d) Performs hair removal;
 - (e) Performs tinting or henna services;
 - (f) Performs lift/perm and lamination services;
 - (g) Performs eyelash or eyebrow extension services
 - (h) Performs basic makeup applications

<u>Hairstylist</u>

The trade of Hairstylist underwent regulatory amendments to the following areas:

- Definition
- Ancillary Activities
- Exclusions
- Term of Apprenticeship

The Term of Apprenticeship was updated to the following extent:

- Former:
 - (a) Level one consisting of a period of at least 12 months during which the apprentice must complete **1,500 hours** of practical experience and technical training; and

- (b) Level two consisting of a period of at least 12 months during which the apprentice must complete **1,500 hours** of practical experience.
- Current:
 - (a) Level one consisting of a period of at least 12 months during which the apprentice must complete **1,800 hours** of technical training and practical experience; and
 - (b) Level two consisting of a period of at least 12 months during which the apprentice must complete **1,800 hours** of practical experience.
