PRESSURE WELDER TESTING AND LICENSING PROCESS

ITS20-008 Revised: April 24, 2025

Inspection and Technical Services (ITS) no longer provides the service of performance qualification testing or retesting, of pressure welders and brazers in Manitoba.

"**pressure welder**" – means a person who acts as a welder, welding operator, brazer or brazing operator in respect of a boiler, pressure vessel or piping used in connection with a boiler or pressure vessel.

A person wishing to obtain or renew a pressure welder's license must contact an approved testing provider to complete the performance qualification testing. A current listing of approved companies can be found on page 2 of this bulletin.

ITS will continue to issue the licenses in accordance with the Steam and Pressure Plants Regulation.

Process:

- An individual will contact one of the approved testing provider and arrange a time to complete the performance qualification testing. The individual will pay the provider a testing fee, as set by the provider.
- Upon successful completion of the performance qualification testing, the testing company will provide the welder with a signed copy of the Welder Performance Qualification Report (WPQR).
- The welder must then make an application to ITS for the license, including paying the licensing fee. A completed application form and a copy of the WPQR is required.

NOTE: Do not send credit card information through the mail or email. Credit card information can be taken over the phone.

- Once the application and license fee are received, issuance of the license may take up to 7 days. During this period, the welder will be allowed to work for 7 days from the date of payment.
- ITS will mail the license to the address listed on the application form.
