

**CRIMINAL PROPERTY FORFEITURE FUNDING
FOR VICTIMS OF CRIME**

- \$70,000 for Candace House, which provides a safe and comfortable refuge near the Law Courts for victims of serious crimes to rest, debrief about court and participate in therapy while involved in the criminal justice process;
- \$45,000 for the Laurel Centre to provide therapy to women who have been victims of child or adolescent sexual abuse;
- \$25,000 for the Salvation Army's Peace of Mind support groups, which bring together women who have experienced abuse and violence in their intimate relationships;
- \$30,000 for Sage House's Sisters Offering Support program, which provides connection and support for women, including transgender women, who have been victims of crime and who have experienced sexual exploitation;
- \$30,000 for Survivors Hope Crisis Centre's Sexual Assault Recovery and Healing (SARAH) program, which provides sexual assault crisis support services for victims of sexual assault in eastern Manitoba including Selkirk, Oakbank, Beausejour, Pinawa, Lac Du Bonnet and Powerview-Pine Falls;
- \$30,000 for the Thompson Bereavement Support Group through Nisichawayasihk Cree Nation Family and Community Wellness Centre Inc., which delivers a variety of programs across the spectrum of prevention, early intervention and positive proactive services and seeks to address the inter-generational effects of trauma on Indigenous and Métis people in Thompson and the surrounding areas;
- \$30,000 for Ndinawemaaganag Endaawaad Inc. (Ndinawe) Child and Youth Care Practitioner Program, which delivers a 10-month training program for individuals with a history of sexual exploitation to receive a Child and Youth Care Practitioner certificate from Red River College;
- \$30,000 to Ka Ni Kanichihk for Wiping Away the Tears, an annual gathering for families of missing and murdered indigenous women and girls (MMIWG) that hosts approximately 125 to 150 family members from Manitoba and northeastern Ontario; and
- \$15,000 for MADD Canada for its annual National Conference for Victims of Impaired Driving in Toronto, which brings together victims and survivors from across the country to participate in workshops relating to coping with trauma and life-altering experiences, as well as sessions on the justice system and victims' rights.

Additional enhanced supports include:

- \$5,000 for RESOLVE, which provides data analysis to assist Manitoba Justice officials in policy and program development, and provides community service providers and police with an analysis of the justice system's response.;
- \$65,000 for independent legal counsel for sexual assault victims;
- \$8,000 for elder support through Eyaa-Keen Healing Centre to assist victim services in southern Manitoba;
- \$8,000 for elder support through MKO to assist victim services in northern Manitoba;
- \$10,000 for Milan, the province's intervention dog;
- up to \$50,000 for family members of homicide victims to travel to court;
- \$3,500 for the CELL program; and
- \$4,000 for the SafeTracks program.
