Aimée Craft (Traverse Bay) - associate professor in the faculty of law at the University of Ottawa. Previously, Craft was the director of research for the National Inquiry into Missing and Murdered Indigenous Women and Girls and the director of research for the National Centre for Truth and Reconciliation. Some of the honours Craft has received include the faculty of law's Distinguished Service Award, University of Ottawa's Knowledge Mobilization Award, Canadian Bar Association's President's Award, Order of Ontario and numerous book awards. Craft has a master of law and society from the University of Victoria, bachelor of law from the University of Ottawa (French Common Law Program), and bachelor of arts jointly from the University of Manitoba and Université de Saint Boniface.
