Update: Provincial Implementation Plan for the Stevenson Report*

INTRODUCTION

The Stevenson Report (*entitled Maples Personal Care Home (PCH) COVID-19 Outbreak: External Review Final Report*) was released in January 2021. <u>Public interim updates</u> were released in March, May and August. The final public report will be released at the time of the project's closure in January 2022. This is an interim update.

Included are updates on the thirteen work groups' progress towards provincial implementation of the seventeen recommendations outlined in the External Review Final Report. (Please refer to previous public reports for the structure of the work groups and the expected outcomes for each of the recommendations.)

Eight of the recommendations and a portion of another were completed by the end of June 2021 and outlined in the August public progress report, including work led the Winnipeg Regional Health Authority and Shared Health on site-specific recommendations for the Maples Long Term Care Home. In the following three months, the goal has been to advance work provincially on the remaining recommendations, with some ending in December 2021 and others continuing to advance in 2022.

At the time of this update, work is complete on a portion of recommendation eight (8B) and all actions related to recommendation nine (9).
