UNDER UNFILED REGULATIONS

The Board of the Manitoba Naturopathic Association has made amendments to the following Clauses of the Regulations:

4(1) Annual meeting of the association

The annual meeting of the Association must be held within 120 days of the fiscal year end of the Association at such time and place as may be decided by the board for the purpose of receiving the annual report of the board, including the annual financial statements and auditor's report of the Association, and the reports of officers and committees. Written notice of the meeting signed by the registrar must be mailed or emailed to each registrant at his or her address as it appears on the books and records of the Association, not less than 10 days before the meeting.

5(4) Voting procedure

The members of the board must be elected by the registrants voting by ballot cast at the annual meeting of the association.

5(6) Notice to elected candidates

The registrar must immediately inform in writing those candidates elected who were not in attendance at the annual meeting.

6(2) Board members eligible for re-election

Each member of the board, if otherwise qualified, is eligible for re-election for an additional term or terms, to a maximum of five consecutive two-year terms

7(1) Board Meetings

At least two meetings of the board must be held each year at such place within Manitoba as the board may from time to time designate; a member may attend a board meeting by electronic means so long as that board member can be heard by all others in attendance. One meeting must be the annual meeting of the board, which is the first Board meeting after the annual meeting of registrants, and must be held no later than thirty days after the annual meeting of the Association.

The Registration Committee has been dissolved; clauses pertaining to the Registration Committee have been removed from the Regulations.

14(2) Registers

The Registrar shall maintain a register of members of the Association.

16 Maintaining the Register

16(1) The register of the college must be open to inspection by any person free of charge at all reasonable times during regular business hours.

17 Types of Registration

The following classes of registrants are established:

- (a) full;
- (b) non-practicing;
- (c) temporary

23(1) Registration

An applicant is eligible to be registered as a full registrant if the board upon recommendation of the examination committee is satisfied that all of the requirements of sections 18, 19 and 20 are fulfilled and shall be so registered upon receipt by the registrar of proof that the applicant meets the liability insurance requirements of section 66.

23(2) Refusal to register

If the board is not satisfied by proper evidence that an applicant is eligible for registration as a naturopathic doctor, the registrar (a) shall refuse to register the applicant; and

- (b) shall notify the applicant in writing of the decision to refuse the registration of the applicant and the reasons for the decision.
- 29-32 The Conditional Registration category has been dissolved; all clauses pertaining to Conditional Registration have been removed from the Regulations.
- 35-37 The Student Registration category has been dissolved; all clauses pertaining to Student Registration have been removed from the Regulations.
- 95(2) This clause has been removed from the Regulations.

Le Conseil d'administration de l'Association des naturopathes du Manitoba a apporté des modifications aux clauses suivantes de ses règlements :

4(1) Assemblée générale annuelle de l'Association

L'assemblée générale annuelle de l'Association doit avoir lieu dans les cent vingt (120) jours suivant la fin de son exercice financier, aux date et lieu dont décidera le conseil d'administration, afin de recevoir le rapport annuel du conseil, y compris le rapport financier annuel, le rapport du vérificateur ainsi que les rapports des dirigeants et des comités. Un avis écrit de l'assemblée, signé par le registraire, doit être expédié par la poste ou par courrier électronique à chaque personne inscrite à son adresse figurant dans les livres et registres de l'Association, au moins 10 jours avant la date de la tenue de cette assemblée.

5(4) Mécanisme de vote

Les membres du conseil d'administration doivent être élus par bulletins de vote déposés par les personnes inscrites lors de l'assemblée générale annuelle de l'Association.

5(6) Avis aux candidats élus

Le registraire doit informer immédiatement, par écrit, les candidats élus qui n'étaient pas présents à l'assemblée générale annuelle.

6(2) Admissibilité des membres à la réélection

Chaque membre du conseil d'administration, s'il satisfait aux conditions, est admissible à la réélection pour un ou des mandats additionnels, jusqu'à un maximum de cinq mandats consécutifs de deux ans.

7(1) Réunions du conseil d'administration

Le conseil d'administration doit tenir au moins deux réunions par année à un lieu dans les limites de la province du Manitoba tel que le conseil pourrait nommer de temps à autre; un membre peut assister à une réunion du conseil d'administration par moyens électroniques à condition que ce membre puisse être entendu par toute personne présente à la réunion. L'une de ces réunions doit être la réunion annuelle du conseil d'administration, soit la première réunion du conseil suivant l'assemblée générale annuelle des personnes inscrites, et doit avoir lieu dans un délai de pas plus de trente jours suivant la date de l'assemblée générale annuelle de l'Association.

10 Le Comité de l'immatriculation a été dissout; les clauses relatives au Comité de l'immatriculation ont été supprimées des règlements.

14(2) Registres

Le registraire tiendra un registre des membres de l'Association.

16 La tenue du registre

16(1) Le registre du collège doit être mis à la disposition de toute personne pour fins d'inspection, sans frais, à tout moment raisonnable durant les heures ouvrables régulières.

17 Types d'immatriculation

Les catégories d'immatriculation suivantes sont établies :

- (a) membre de plein droit;
- (b) membre non-praticien;
- (c) membre provisoire.

23(1) Immatriculation

Un demandeur est admissible à l'immatriculation à titre de membre de plein droit si le conseil, sur recommandation du comité d'examen, est convaincu que toutes les exigences des sections 18, 19 et 20 sont satisfaites et il sera ainsi inscrit dès que le registraire reçoit une preuve satisfaisante que le demandeur répond aux exigences d'assurance-responsabilité de l'section 66.

23(2) Refus à s'enregistrer

Si le conseil n'est pas convaincu par la preuve pertinente qu'un demandeur est admissible à l'immatriculation à titre de médecin en naturopathie, le registraire

- (a) refusera l'immatriculation au demandeur; et
- (b) informera le demandeur par écrit de la décision de son refus à l'immatriculation, et les motifs de cette décision.

 - (b) at least once in each of two weeks during the twelve month period aforementioned in an issue of a newspaper having a general circulation in the area of the province in which the persons or a majority of the persons, who would be interested in or affected by the Private Bill reside;

a notice in English and French in the form set out in Appendix A-1, signed by or on behalf of the petitioner and clearly and distinctly specifying the nature and object of the petition and any exceptional provision proposed to be inserted in the Bill.
