Date:June 24 , 2015Order in Council No:238/2015Recommended by:Minister of Tourism, Culture, Heritage, Sport and Consumer Protection

Order

The Magna Carta Issue of 28 March 1300 and The Forest Charter of 1300 are determined to be objects of cultural significance from a foreign country and the temporary exhibition or display of these works and objects in Manitoba by The Canadian Museum for Human Rights is in the interest of the people of Manitoba.

AUTHORITY

The Foreign Cultural Objects Immunity from Seizure Act, C.C.S.M. c. F140, states:

Immunity from seizure of foreign cultural objects

1 When any work of art or other object of cultural significance from a foreign country is brought into Manitoba pursuant to an agreement between the foreign owner or custodian thereof and the Government of Manitoba or any cultural or educational institution, providing for the temporary exhibition or display thereof, in Manitoba by the Government of Manitoba or the cultural or educational institution, no proceeding or action shall be taken or permitted in any court and no judgment, decree or order shall be enforced in Manitoba for the purpose of, or having the effect of depriving the Government of Manitoba or the institution or any carrier engaged in transporting the work or object within Manitoba, of the custody or control thereof, if, before the work or object is brought into Manitoba the Lieutenant Governor in Council where the agreement is with the Government of Manitoba, on the recommendation of the member of the Executive Council who executed the agreement for and on behalf of the Government of Manitoba and where the agreement is with a cultural or educational institution, on the application of the institution determines

- (a) that the work or object is of cultural significance; and
- (b) that the temporary exhibition or display thereof in Manitoba is in the interest of the people of Manitoba;

and the Order in Council is published in the Manitoba Gazette.

BACKGROUND

1. The Canadian Museum for Human Rights has entered into an agreement with Durham Cathederal of Durham, England, to borrow the following cultural objects for temporary exhibition or display in Manitoba as part of the exhibition "Magna Carta; Law, Liberty, Legacy":

The Magna Carta Issue of 28 March 1300, DCD 2.2. Reg.2

The Forest Charter of 1300, DCD 2.2.Reg.8.

- 2. The objects will be on exhibit to the public from August 15, 2015 to September 18, 2015. The objects are scheduled to arrive in Winnipeg on August 1, 2015 and to leave on September 24, 2015.
- The Canadian Museum for Human Rights has applied to the Lieutenant Governor in Council under section 1 of the Act for a determination that these objects are of cultural significance and that the temporary exhibition or display thereof in Manitoba is in the interest of the people of Manitoba
