Kordhintaa Kirada

Inta badan kiisaska, milkiilaha hantida wuxuu sharci ahaan kordhin karaa kirada hal mar 12dii bilood. Sannad kasta, dawladda waxay xad u sameeysa xisaabta lagu kordhin karo kirada. Xadkaan waxaa lagu magacaabaa nidaamka kordhintaa kirada. Sidee ayuu milkiilaha hantida u kordhin karaa kirada?

Milkiilaha hantida waa in uu kiraystaha siiyo ogeysiis ku saabsan kordhintaa kirada muddo saddax bilood. Ogeysiiskaan waa:

- in uu qoran yahay
- in uu muujiyo inta kirada tahay iminka
- in uu muujiyo inta kirada noqon donto, doolar ahaan iyo boqolkiiiba xisaabta (tusaale ahaan: tan waa kordhin la'eg \$15.00 ama 3%);
- in uu sheego inta milkiilaha hantida loo ogol yahay in uu ku kordhiyo kirada
- in uu sheego taariikhda kordhintaa bilaaban doonto
- in uu sharaxo in kordhintaa aysan ahayn sharci haddii kiraystaha aan la siinin saddax bilood oo ogeysiis ah
- in uu muujiyo nidaamka u dagsan kordhintaa kirada sannad kasta, tusaale ahaan 1.5%
- in uu sheego in kiraystaha xaq u leeyahay in uusan waafaqin xisaabta lagu kordhiyay kirada

Sidoo kale, milkiilaha hantida waa in uu Laanta Kirada Deegaanka siiyo ogeysiis qoran oo ku saabsan kordhintaa kirada muddo 14 maalin gudahooda kaddib marka uu u sheego kiraystaha.

Maxay sameeyn karaan kiraystayaasha?

Haddii kiraystaha uusan waafaqin xisaabta lagu kordhiyay, waxay warqad gaarsiin karaan Laanta Kirada Deegaanka, taasoo sharaxaysa sababta. Warqadda waa in ay soo gaarto Laanta ugu yaraan muddo 60 maalin ka hor inta kordhintaa kirada aysan bilaabanin.

Kordhintaa ka sareeyso inta ugu badan

Milkiileyaasha raba in ay kirada ku kordhiyaan in ka sareeyso inta ugu badan waa in ay marka hore ogolaasho ka helaan Laanta Kirada Deegaanka. Milkiilaha waa in uu qoraal ku soo dalbado ogolaashada. Qaadashada racfaan la xariira go'aanka

Haddii milkiilaha hantida ama kiraystaha aysan isku waafaqin go'aanka kordhintaa kirada, waxay xaq u leeyahiin in ay racfaan ka qaataan una gudbiyaan Guddiga Kirada Deegaanka oo laga helo 1650-155 Carlton Street, Winnipeg MB R3C 3H8, muddo 14 maalin gudahooda laga bilaabo marka la helo go'aanka Laanta Kirada Deegaanka.

- unugyada kirada cusub; haddii dhismaha la daggan yahay la dhisay lana daggay bisha Abril 9, 2001 kaddib, waxaa laga dhaafaa muddo 15 sanno; haddii dhismaha la daggan yahay la dhisay lana daggay bisha Maarsa 7, 2005, waxaa laga dhaafay muddo 20 sanno
- unugyada lagu kirayo in ka badan xisaab cayiman; waxaa isbedeli kara xisaabtaan sannad kasta; ka saxo bogga internetka Laanta ee laga helo www.manitoba.ca/rtb si aad u heshid macluumaaadka ugu dambeeyo ama si aad ula xariirtid Laanta
- unugyada ay maamulaan, ama loo maamulo, Dawladda Canada, Dawladda Manitoba ama dawladda hoose
- unugyada xanaaneyaha/shaqaalaha
- dhismooyinka laga kirayo qofka ilaa inta uu nool yahay, kuna saleysan maamulka samofalka
