Crown Services	Requests access to all briefing and advisory notes regarding the government's 15% management reduction at Manitoba Liquor and Lotteries and all records of reductions.
Crown Services	Requests access to all briefing and advisory notes regarding the government's 15% management reduction at Manitoba Public Insurance and all records of reductions.
Education and Training	Requests access to records of how the Canada-Manitoba Job Grant has been disbursed in 2015, 2016 and 2017.
