	WHEREAS on May 2, 2012, two children under the age of four left Down to Earth Children's Centre (the Centre) unescorted by any staff and crossed a busy intersection (Corydon Avenue) without an accompanying adult. It has been reported that after having been missing for 30 minutes, the children were located by a citizen and Winnipeg Police Service approximately 1 kilometre away from the Centre.	
	In reviewing the Centre's Record of Child Care Employees, it was also noted that the licensee currently fails to meet the requirements for trained staff.	
	AND WHEREAS the foregoing violates <i>The Community Child Care Standards Act</i> ("the Act") section 3(1), which states:
