	WHEREAS it has been reported to Manitoba Early Learning and Child Care ("MELCC") that on August 26, 2014, during outdoor play, a 4 year old child attending Fuzzy Bears Inc. (the "Centre") was left at the Sportsplex Park located in Brandon, unsupervised by any Centre staff.	54
	As reported by a Child Care Co-ordinator (CCC), at approximately 11:50 a.m. on August 26, 2014 while conducting a monitoring visit at a family child care home (FCC) located near the Sportsplex Park, school age children attending the FCC alerted the family child care provider and CCC that a young preschool child was walking alone near the entrance ramp to the Sportsplex building. The CCC observed two adults and a group of children walking down the street near the school where the Centre is located. The family child care provider along with the children in her care immediately went to the Sportsplex to retrieve the child and reunited the child with the group from the Centre.	
	The CCC also reported having contacted the Centre and its site supervisor confirmed that Centre staff had gone to the Sportsplex Park for an outing.
