	WHEREAS it has been reported to Early Learning and Child Care (ELCC) Program that a two year old child, enrolled at Shilo Military Family Resource Centre Inc. operating as Shilo MFRC Daycare (the "Centre"), was left outside at a community playground unsupervised by Centre Staff.	
	According to the Centre's incident reports, the incident occurred on October 6, 2016, at the approximate identified times. As reported, at 10:00 a.m. three Centre staff took 11 (8 preschool and 3 infants) children in strollers to a community park to play. A head count of the children was conducted at 10:40 a.m. at which time 11 children were present and accounted for. At 11:10 a.m. the group left the park and returned to the Centre; as children were sitting down for lunch at 11:30 a.m., a Centre staff realized one child was missing. A military member came to the Centre at 11:35 a.m. to inform staff that a child wearing a blue MFRC pinny was on the corner of Royal Avenue and Notre Dame Avenue. The Centre staff went and retrieved the child and returned to the Centre.	
	AND WHEREAS , the licensee fails to meet <i>The Community Child Care Standards Act</i> and Manitoba Regulation 62/86 as hereinafter provided.
