| | WHEREAS on May 9, 2023, Division staff received confirmation from Aizeyosabo Ekuase (the "Licence Holder") that care was being provided to 12 infant and preschool aged children, which exceeds the number and ages of children permitted to be cared for as noted on the family child care home licence. Division staff directed the Licence Holder to immediately reduce the number of children cared for at one time to be in compliance with the terms and conditions noted on the licence. The Licence Holder failed to advise Division staff of compliance with the terms and conditions noted on the licence by 10:00 a.m. on May 10, 2023. | |
| | Division staff attended the premises on May 10, 2023 to determine if the Licence Holder was in compliance with the terms and conditions noted on the licence. Division staff were granted entry to the family child care home by an unknown adult who identified themself as a staff and indicating it was their first day. Division staff observed 11 children (4 under the age of 2 years and 7 between the ages of 2 and 6 years of age) in the care of this unknown adult. Attendance records confirmed 11 children in care as well as a 12th child who attended earlier in the day and departed at 12:45 p.m. as well as a 13th child who had not yet arrived. | |
