	WHERAS it has been reported to Early Learning and Child Care (ELCC) Program that an incident occurred on November 28, 2018 at Stars of Promise Inc. (the Centre) whereby a three-year old preschool child, was left inside the building during an emergency evacuation drill of the Centre. The remaining children and staff safely evacuated from the Centre.	
	According to the Centre staff's incident reports and the Centre Director's review of the Centre's video monitor, the emergency evacuation began at approximately 10:15 a.m. on Wednesday November 28, 2018. Children were evacuated out of the building using multiple exit routes and returned inside, using one main door, at 10:20 a.m.	
	At approximately 11:00 a.m. while children were dressing to go outdoors, Centre staff noticed the three-year old child's winter clothing still in a locker. The preschool child however, was unaccounted for.	
	Several minutes later, the three-year old child was located in a locked hallway, along one of the emergency evacuation routes.
