To Centre Directors, Board Chairs and Home-Based Providers:

This circular is a reminder of your responsibility to submit complete attendance reports for all children enrolled in your facility in a timely manner. The attached policy outlines the attendance reporting requirements for centres, nursery schools and home-based providers, in receipt of provincial operating funding.

All funded early learning and child care facilities are required to submit a monthly attendance report, even if a facility does not have any subsidized families in enrolled.

Attendance information for all children, including children whose families do not receive a fee subsidy must be included on the report.

Funded facilities must complete and submit a *Facility Child Attendance Report* through the Child Care Online system within 30 days of the end of each four-week attendance reporting period.
