Moving Forward on Child Care Priorities

On August 1, 2023, Manitoba and Canada announced new action plans under two of its existing agreements with the Government of Canada: the Canada-Manitoba Early Learning and Child Care Agreement and the Canada-Manitoba Canada-Wide Early Learning and Child Care Agreement. They outline actions that Manitoba will undertake to achieve its commitments to strengthen the workforce, enhance quality, improve affordability, and create 23,000 additional spaces.

A variety of space creation pathways announced earlier this year have enabled work towards space targets including those at existing and new child care facilities, at post-secondary institutions, and at new and existing schools across the province. As of August 2023, a total of 12,498 spaces have opened or been committed to children from 0 to 12 years of age. This includes 8,266 spaces approved for 0- to 6-year-olds (opened or committed) leveraging federal funding and an additional 4,272 spaces approved to extend supports to school-aged children ages 7 to 12 (opened or committed) through provincial funding investments.

Highlights of continued progress include:

- Eight new child care centres built under the Municipal and Indigenous Governing Bodies capital stream using a ready-to-move (RTM) build approach are now open, including Île-des-Chênes, Whitemouth, Oak Bluff, Stonewall, East Selkirk, Portage la Prairie, and Rosenort in addition to Bright Beginnings Educare in Headingly that opened in July. Each facility was built and operational in approximately one year and added 74 infant and preschool spaces to their respective communities. Another six RTM child care projects are currently under construction, with 11 projects remaining to commence in early 2024.
- Preparations for upcoming stakeholder consultations this winter, led by selected proponent MNP, to inform modernization of the certification framework.
- Additional strategies to recruit and retain professionals in the sector are in development, including expanded
 post-secondary training seats and child care programming, cross-jurisdictional work on a federal-provincialterritorial workforce strategy, as well as the Minister's Consultation Table, which comprises providers and
 stakeholders

Strengthening the Circle of Security (COS)

As efforts continue in areas of child care space creation and workforce expansion, it is recognized that access to responsive, quality learning opportunities for educators contributes to the development of quality childcare environments where children can thrive.

Under the original Canada-Manitoba ELCC Agreement (2017-2020), investments were made towards the development and implementation of the Circle of Security (COS) course, an early intervention program designed to strengthen the relationship between a caregiver and a child, supporting child care providers in gaining competence in helping children manage their emotions and hence their behaviors.

Child care providers who have taken COS training have suggested experiencing beneficial outcomes such as reductions in behavioural outbursts and improved confidence of staff.

While investments for COS programming continue under the 2023-2025 Canada-Manitoba ELCC agreement, management of the COS program along with its funding source was transferred from Early Learning and Child Care to New Directions CARE (Childcare Attachment and Relationship Education) program.

Through the CARE mandate and the capacity at New Directions to support programming growth, child care directors and staff can:

- access COS facilitator training at no charge
- receive valuable mentorship to maintain fidelity to a rich COS model and access to Community of Practice sessions
- connect, as trained facilitators, with other centres wishing to receive this course with funding also available to reimburse facilitators for their time

In addition, the Reaching Out subprogram of CARE, offers child care providers attachment and trauma focused workshops and consultation/referral opportunities to family therapy services.

Mamàhtawisiwin Symposium

On November 14 and 15, 2023, close to 800 individuals whose work impacts and influences the learning and development of children in child care settings and within the Kindergarten to Grade 12 education system, gathered at the Mamàhtawisiwin Symposium at the Victoria Inn and Conference Centre.

Mamàhtawisiwin: The Wonder We Are Born With—an Indigenous Education Policy Framework established in 2022 supports the achievement of First Nations, Métis, and Inuit learners by helping educators to incorporate Indigenous languages, cultures, and identities into their teaching and practices, setting Indigenous students up for success in school and beyond.

This years' symposium included over 130 representatives from the early learning child care sector, along with Elders and Knowledge Keepers, students, teachers, superintendents, senior post-secondary administrators, government staff, and community partners who engaged on the Indigenous Education Policy Framework and considered opportunities for its expansion to child care. The two-day agenda followed an in-depth look at each of the Strategies and Actions within the Policy Framework:

- Authentic Involvement
- Putting Children/Students at the Centre
- Understanding World Views, Values, Identities, Traditions, and Contemporary Lifestyles
- Inclusive and Culturally Safe Learning Environment

The symposium provided opportunities for participants to share their stories and achievements in reaching successful outcomes for Indigenous children and youth, and to build their skills and knowledge base with a variety of informative workshops and breakout sessions.

Listening to Manitoba's Early Childhood Educators

Meet the ELCC Team—Taryn Bennett, Inclusion Support Program Coordinator, Ballet Instructor

"I always knew I wanted to work with children. I started as an ECE. I'm interested in brain development, and I am really passionate about sharing what I know and understand: how to support children and make sure that we meet their needs, how we speak to children, and how we emotionally support them to be resilient. I'm a dance instructor. I've danced since I was three. I teach ballet, jazz, and tap. I've had some wild ballet teachers before, but I like to think of myself as someone more fun. Within my studio, I'm one of the senior teachers so I'm able to share a lot of knowledge in this line of work, like classroom management and how to support children who are struggling. I serve as sort of a mentor as well, which is interesting. So, both worlds kind of collide. I have taught children from the age of two to adults. But right now, my interests and where I love to be is with preschool-aged children. Most of my classes at this point in my life are preschool. I teach the same children for a whole dance season, 10 months of the year, so I get to know them very well. It's nice too, because prior to this job (ISP coordinator), I was working with children. I was around them all the time, and now I'm affiliated with them in a way where I don't actually work with them directly, so [being an instructor] sort of fills that void."
