- The construction of a pathway system to interconnect various destinations within the Town will
 upgrade aging and deteriorating narrow sidewalks and provide access along the former railway
 that bisected the Town.
- The Active Transportation System of Asphaltic Pathways will interconnect existing pathways as part of the overall multi-use pathway system for the community.
- The pathways will provide a safe and easy to use facility for pedestrians, cyclist and small-wheel users that will interconnect the various origins and destinations within the community.

As the Asphaltic Pathways System continues to expand, maintenance of the facilities will continue to be done by the Town's Public Works Department as an infrastructure asset.

At this juncture no partnerships or outside agencies have been involved, but it is our understanding that a regional trail/pathway is being looked at and connecting to this regional trail will be a future consideration.




Please review the revised map. We took off First and Third Streets and added the section on Fifth Street. None of the proposed areas currently have sidewalks.

Thank you for your application to the 2016 intake of the Small Communities Transportation Fund (SCTF) for the 2016 Active Transportation System Asphaltic Pathway Construction Project. This program is part of the Federal Gas Tax Fund, which provides funding support to rural Manitoba communities to develop new active transportation infrastructure.

Applications for funding under this program are reviewed and scored based on the criteria set in the program guidelines. At the close of the SCTF 2016 intake, the province received a large volume of high ranking eligible applications, far exceeding the available funding.
