For the first time, Manitobans have real choices and real flexibility.



Our priorities continue to be eliminating the debt; improving health care and education; making communities safer; keeping our taxes competitive; encouraging more investment; and creating more jobs. SECURING THE FUTURE

...for our Children

Support for children, youth, and families increased significantly, including:

- \$2.6 million for pre- and early-school programs, including early literacy
- \$2.1 million for early childhood nutrition initiatives
- \$2.3 million for positive parenting programs, healthy child development, strategies to avoid adolescent pregnancies and prevent fetal alcohol syndrome
- \$4.8 million more for accessible, flexible, and portable child care options
- \$4.2 million more for curriculum development, standards and testing
- \$60 million for school capital construction and upgrading



...with Education, Skills, and Jobs

- \$4 million more for scholarship and bursary support – bringing the level to \$5 million – which is expected to benefit 10,000 students beginning in 1998
- \$1.6 million for new Interest Relief and Debt Reduction Programs for post-secondary students and graduates
- \$15 million for Manitoba's unique Learning Tax Credit
- \$7.1 million for youth employment programs benefitting 15,000 students this year
- \$3 million to expand the apprenticeship program
- \$10 million more for university and community college operating grants
- \$14.6 million for *Making Welfare Work* and other programs to help Manitobans secure jobs.


Better Health Care

Over \$100 million more for health care in this Budget despite significant federal cutbacks. We allocate 34.6% of expenditures to health care – second-highest in Canada – \$1,700 per woman, man, and child.

- \$10 million more to purchase medical equipment
- \$11 million more for dialysis
- \$4.5 million more for care in personal care homes
- \$2.5 million to reduce waiting lists
- \$2.4 million more to support additional intensive care beds and expansion of neurosurgery
- Home care up \$23 million to \$123 million, triple the 1987 budget
- \$600,000 more for a Provincial Diabetes Initiative
- \$670,000 for the mobile breast cancer screening program
- \$7.3 million more for Pharmacare
- Continued commitment of \$770,000 for the Aboriginal Health and Wellness Centre

Total expenditure on health care is \$1.93 billion, up about 45%, or \$600 million, from 1987/88.

Balanced Budgets Sharing the Benefits

TAX CUTS

- A two-point cut in Manitoba's Personal Income Tax rate, to 50% of basic federal tax. You will see the benefit on your paycheque starting July 1, 1998. Manitobans will pay about \$60 million less in provincial personal income taxes next year.
- The sales tax rebate of up to \$2,500 for first-time buyers of a new home is extended until April 1, 1999.
- The sales tax on custom-developed software is removed to help businesses cope with Year 2000 issues.
- Payroll tax rate cut to 2.15% from 2.25%. Over 95% of Manitoba businesses are already exempt from this tax.
- Corporation Capital Tax exemption increased to \$5 million.

Manitoba's Savings Account

This year we are taking \$226 million from the Fiscal Stabilization Fund for one-time priority projects, including:

- \$75 million to double our debt repayment to \$150 million
- \$60 million to bridge federal funding cuts for health, education, and support to families
- \$41 million to cover flood costs and flood-proofing
- \$50 million to fund special capital initiatives, such as \$5 million for residential street repair in Winnipeg and \$5 million for highway construction

This will bring the March 31, 1999 Fund balance to about \$340 million. Another \$50 million has been targeted for special capital initiatives in 1999. By law, the targeted minimum balance in this Fund is 5% of expenditures – around \$280 million.

Freeing our Children from the Burden of Debt


Our balanced budget legislation sets a mandatory schedule for Manitoba to pay down its debt. During Budget consultations, Manitobans placed a high priority on paying down the debt even faster if possible. So this year, we will increase our debt repayment to \$150 million, double the \$75 million required.

Balanced Budgets 4 Years Running!

...and Stronger than ever!

- employment growth up 2.4%, the strongest increase in 11 years; this brought our unemployment rate down to its lowest level since 1981
- retail sales up 6.9%, the largest increase in 12 years
- manufacturing shipments up 11.5% to reach a record \$10 billion
- exports to the US are triple the 1990 level
- private investment up 14.8% in 1997, the seventh consecutive increase
- farm cash receipts up 9.9%, or 2.5 times the national increase

Balanced Budgets Sharing the Benefits

Infrastructure and Research

- \$170 million to improve our highway system
- \$63 million for 26 health capital construction projects
- \$5.3 million for a new Nursing Faculty building at the University of Manitoba
- \$60 million for school capital construction and upgrading
- New and enhanced research and development initiatives total \$25.5 million, including:
 - \$7 million for the Manitoba Innovations Fund to support world-class scientific, health, engineering, and environmental research infrastructure
 - \$2 million for the Health Research Initiative
 - \$5 million to create the Manitoba Science and Technology Fund
 - \$6.5 million for the Agri-Food Research and Development Initiative
