2018 Renewals

If you have not received your 2018 licence and decals please contact the Taxation Division - see our contact information below.

Please note that IFTA credentials will not be renewed if there are:

- Delinquent tax return(s)
- Tax(es) owing under IFTA
- Tax(es) owing under other tax statues administered by the Taxation Division

If you do not renew by February 28th, 2018, your IFTA account will automatically be closed.

Important!!

Split Tax Rates for Newfoundland and California

For the 4th Quarter 2017, the following split tax rates are in effect:

Newfoundland (Gasoline)

October 1st - November 30th: rate is 0.2450
December 1st - December 31st: rate is 0.2050

California (Diesel)

October 1st - October 31st: rate is 0.1196
November 1st - December 31st: rate is 0.1842

Office Closures

March 30th, 2018 (Good Friday)
April 2nd, 2018 (Easter Monday)



Fourth Quarter Due Date: Wednesday, January 31st, 2018

To avoid penalties and interest, returns must be filed by the above date. Please see payment options below.

IFTA Decals—Important Information

The proper placement of IFTA decals will help you avoid costly delays on the road. See information below:

- Manitoba Taxation and the IFTA Law Enforcement Committee require that valid IFTA decals are affixed on the exterior portion of both sides of the cab.

- Do not place IFTA decals on windows, mirrors, tanks or vents.
- Do not use a pressure washer directly on the decals.
- Please remove all expired or non-valid deals from your vehicle.

These are accepted as an original tax return. Do not send us a duplicate return.

Returns that are not received will be considered late filed and penalty and interest will be assessed.
