4. Adding a pre-arrival page to CPM's website to provide guidance on actions that could help potential applicants prepare for the registration process before coming to Canada.	See above under #2	Spring 2017	Complete	A pre-arrival page has been added that includes a link to CAPR's pre-arrival information. CAPR's pre-arrival information includes an overview of the profession in Canada, access to a self-assessment readiness tool to help people understand the practice, helpful tools such as a cost estimator, and links to important resources such as settlement agencies and loan programs. The webpage also includes source country profiles that allow potential applicants to learn about candidate success on licensing examinations by country of education and how specific international educational programs compare to Canadian Physiotherapy programs. At time of writing, CAPR had information on its 25 top source countries.  Information on financial resources on CPM's site has been updated to link to immigratemanitoba.com pages to remain current.
5. Continued discussions with the Faculty of Health Sciences (College of Rehabilitation Sciences) at the University of Manitoba regarding opportunities to include IEPs along with local graduates to practice skills in a lab setting, ideally with oversight by physiotherapy professors at the university.
