	<p>On April 28, 2006, the Manitoba Child Care Program was informed of an incident which occurred on April 25, 2006 whereby an infant was left inside the child care centre while the remaining children and staff were safely evacuated from the facility during an evacuation of the school.</p> <p>On May 2, 2006, Mr. Glenn Wiedermann, Child Care Co-ordinator, went to the facility to investigate this complaint and received information that confirms that the following incident did actually occur. In addition, the centre staff had not kept a record of the incident and the parent whose child was left behind had not been notified. Mr. Wiedermann also reviewed documentation from past evacuations which supports that fire drills were not held between the hours of 11:00 a.m.- 3:00 p.m.</p> <p>Based on this information Manitoba Child Care Program has determined that there have been violations to:</p> <p><i>The Community Child Care Standards Act</i> section 3(1) which states-</p> <p>Responsibility to provide proper environment- Every person providing child care shall at all times provide an environment that is conducive to the health, safety, and well-being of the children.</p>

	<p>And to,</p> <p>Manitoba Regulation 62/86, sections 10 (6) Daily Record and 17 Evacuations.</p> <p>Section 10(6) states that: Every licensee shall maintain a written record of every incident which affects the health, safety or well-being of children and staff. Under the guideline it states: "The purpose of the daily incident report is to enhance communication between staff and a child's parents or guardians. Daily incidents.....should be recorded and shared with parents daily.</p> <p>Section 17 states that: Every licensee shall ensure that: (e) emergency evacuation procedures are practiced at least once a month for all children in attendance at the licensee's child care centre, and written records are kept indicating the date and time of each drill and the number of staff and children evacuated and are maintained on file for a period of 1 year. Under the guideline it states: "Plans for evacuating children should also include when children are asleep, as well as different times of the day."</p>

	<p>As a result, the Manitoba Child Care Program is requiring that the following steps be taken:</p> <ol style="list-style-type: none"> 1) The centre must revise its current evacuation procedures immediately to ensure that staff responsibilities are clearly outlined and a copy of the revisions must be submitted to the Child Care Co-ordinator for approval. 2) The centre must conduct an in-depth training session with all the staff, including substitutes, to ensure that they are familiar with the evacuation procedures 3) Evacuation drills must be conducted during various portions of the day including nap time to ensure that staff are aware of all aspects of conducting evacuations throughout the day. 4) The assistance of the Local Fire Authority must be requested in conducting a fire drill at the centre. 5) Evacuation drills must be conducted twice a month, recorded and documentation submitted to the Child Care Co-ordinator until further notice. 	<p>WITHIN 1 WEEK</p> <p>2 WEEKS</p> <p>IMMEDIATELY & ON-GOING</p> <p>1 MONTH</p> <p>IMMEDIATELY</p>
