#### Subject: Compensation for Persons Infected with Hepatitis C (HCV)

Further to directives 2001-23 and 2002-70, this directive provides additional information on the compensation available for persons infected with HCV. Compensation programs fall into two groups, based on when the disease was contracted. A person can receive compensation under one group only.

### HCV Contracted before January 1, 1986 or between July 1, 1990 and September 28, 1998

There are two compensation programs for persons who contracted HCV during this period. Persons who contracted HCV in Manitoba may be eligible for both programs.

## Manitoba Hepatitis C Assistance Program (MHCAP)

MHCAP is provides a one-time payment of \$10,000 to persons who became infected with HCV as a direct result of receiving a blood transfusion or blood products in Manitoba before January 1, 1986 or between July 1, 1990 and September 28, 1998. Compensation is also available for persons who contracted HCV indirectly from a person eligible for this compensation, as well as the estate of a person who died from HCV contracted under these conditions. This compensation, as well as compensation from a similar program of another Canadian iurisdiction, is exempt under subclause 8(1)(a)(xi) of the Employment and Income Assistance (EIA) Regulation, except for any portion that is for loss or replacement of income.

#### Pre-1986/Post-1990 Hepatitis C Settlement Fund

Persons who contracted HCV as a result of receiving contaminated blood or blood products anywhere in Canada prior to January 1, 1986, or between July 1, 1990 and September 28, 1998, may be eligible to receive compensation under the Canadian Red Cross Pre-1986/Post-1990 Hepatitis C Settlement Fund. Persons who were infected indirectly by a person eligible for this compensation, as well as family members of an eligible person, also qualify for compensation. This compensation package is exempt under subclause 8(1)(a)(xii) of the Employment and Income Assistance Regulation.

# HCV Contracted between January 1, 1986 and July 1, 1990

Persons who contracted HCV between January 1, 1986 and July 1, 1990, through a blood transfusion or blood products received anywhere in Canada, are covered by a Federal-Provincial-Territorial (FPT) agreement, administered by the federal government. Persons who were infected indirectly by a person eligible for this compensation, as well as family members of an eligible person, also qualify for compensation. The Manitoba government contributes to this federally-administered program.

Under the FPT agreement, persons who are infected with HCV and qualify for compensation may be entitled to the following benefits:

- 1. a fixed payment as compensation for pain and suffering, based upon the individual's medical condition;
- 2. reimbursement for uninsured HCV treatment and medication costs;
- 3. reimbursement for out-of-pocket expenses such as child care, travel, hotels or meals attributable to seeking medical advice regarding HCV;
- 4. up to \$1,000 per month of completed compensable HCV Drug Therapy (e.g., interferon); and
- 5. compensation for loss of income, loss of services in the home and/or the cost of care such as home nursing services.

This compensation is exempt under subclause 8(1)(a)(x) of the Employment and Income Assistance Regulation, except for any portion that is for loss of income or support.

Please ensure that participants with HCV access the compensation available under these programs. In particular, assistance for medical expenses should not be provided by EIA if the participant is entitled to reimbursement under the FPT Agreement.
