II. The Funeral Board of Manitoba

Administrative Structure

In 2019, the Minister of Justice was responsible for *The Funeral Directors and Embalmers Act, The Cemeteries Act and The Prearranged Funeral Services Act* until Oct 22. As of Oct 23, 2019, the Minister of Finance was responsible.

Board members are appointed by the Lieutenant Governor in Council in three-year renewable terms. The Board includes a Chair designated by the Minister, and five other persons of whom two must be licensed funeral directors.

The Chair of the Funeral Board is also the Chief Operating Officer and Director of the Vital Statistics Agency (SOA). This provides a link for death registration processes; permission and oversight of transportation of the deceased to other countries; and disinterments. The Agency also provides administrative and information technology support for the Funeral Board of Manitoba. The Board designates a Vice-Chair and Registrar from the appointed members.

The Board has one employee – an Inspector, who is not a civil servant.

The Board also has three standing committees: the Education Committee, chaired by the Registrar, which reviews continuing education courses for approval by the Board; the Legislative Committee, co-chaired by the Vice-Chair and one other member; and the Ethics Committee chaired by a member who is also a funeral director.

III. Profile

History

In 1967, the Province of Manitoba proclaimed *The Embalmers and Funeral Directors Act,* which created a Board of Administration to oversee the funeral industry.

Although the Act underwent several minor changes in the following years, the first major change occurred in 2006 when the requirement to complete six hours of funeral director and/or embalmer continuing education annually was implemented.

Additional changes:

- 2009: The Act was renamed *The Funeral Directors and Embalmers Act* and was amended to increase the enforcement tools available to the Board, including a *Code of Ethics.* The Board's name was also changed from the Board of Administration to the Funeral Board of Manitoba.
- 2011: Introduction of *The Grieving Families Protection Act.* This Act increased fines for desecration and vandalism of cemeteries under *The Cemeteries Act;* increased the investigative powers of the Board under *The Funeral Directors and Embalmers Act*; and changed significant parts of *The Prearranged Funeral Services Act.*
- 2013: (December 5) Administration of *The Cemeteries Act* transferred from the Public Utilities Board to the Funeral Board of Manitoba.
- 2015: The Board circulated a consultation draft of *The Prearranged Funeral Services Act Regulation* to funeral home owners, directors and other stakeholders. The consultation identified several issues for further study, including the recommendation to review and consolidate all bereavement legislation.
- 2017: (September 1) Administration of *The Prearranged Funeral Services Act* transferred from the Public Utilities Board to the Funeral Board of Manitoba.
- 2018: (November 20) A review of *The Funeral Directors and Embalmers Act, The Cemeteries Act* and *The Prearranged Funeral Services Act* was announced in the *Speech from the Throne,* with a goal of making funeral, burial and bereavement legislation more responsive to the diverse needs of Manitobans.
- 2019: In response to the review of *The Funeral Directors and Embalmers Act, The Cemeteries Act* and *The Prearranged Funeral Services Act* announced in the 2018 *Speech from the Throne,* the Board held consultations with public stakeholders across the province in May, June and October 2019.

Administratively, the Funeral Board of Manitoba has evolved to serve multiple functions:

- Providing consumers with protection in the provision of funeral-related services by regulating the licensure of select professionals, services and facilities as prescribed by *The Funeral Directors and Embalmers Act*, *The Cemeteries Act*, and *The Prearranged Funeral Services Act*. This includes issuing licences to funeral directors and/or embalmers; premises, crematories, and certain cemeteries, mausoleums and columbaria; and prearranged funeral service plan providers involving trust moneys. - Contributing to professional distinction by approving the school specializing in training funeral directors and embalmers in Manitoba; and continuing education courses approved for the professional development of licensees.
- Monitoring compliance and responding to concerns, including investigation of complaints by the Inspector . All written complaints are investigated, and may result in a hearing before the Board or imposition of other disciplinary measures.

Vision

The Funeral Board of Manitoba is committed to improving funeral and cemetery services within a fair, ethical and transparent marketplace.

Mission

Responsible for the protection of public interest, the Funeral Board of Manitoba regulates and supports funeral and cemetery services, sets educational standards and responds to consumer complaints about licensees.

Goals

Education

To provide an educational framework for students and a continuing education framework for licensees to ensure they have the knowledge and skills to provide dignified care to the deceased, and serve their families, the public and the industry.

Accountability

To ensure all licensed cemeteries, crematories, funeral homes, and funeral directors/embalmers provide fair and ethical services to all clients.

Compliance

To ensure cemetery owners, funeral home operators, directors and agents comply with all codes, laws and regulations.

Organizational Stability

To achieve financial sustainability in the fulfillment of its legislative responsibilities.

Values

Collaboration

The Funeral Board of Manitoba consults with decision-makers; the public and the industry, whenever possible.

Continuous Improvement

The Funeral Board of Manitoba is committed to continuous improvement of its forms, processes and policies to better serve Manitobans.

Professional Education

The Act requires all funeral directors and embalmers to take six hours of continuing education each year. The Board approves the courses eligible for Continuing Education and oversees the fulfillment of this requirement.

The Act requires that the Board approve the school(s) for education and training of students. In 2019, the Canadian College of Funeral Service was approved to provide training in the Province of Manitoba.

Communication

The Funeral Board of Manitoba's brochure, *Guide to Roles and Responsibilities,* continues to be distributed by funeral directors to clients and individuals who make inquiries. It outlines the responsibilities of the Funeral Board of Manitoba, those of the funeral directors and the consumers. Each has a role and responsibilities when dealing with the death of a loved one.

Through its website and inquiry line, the Board provides consumers with information regarding their legal rights, including which bereavement products and services are required by law and which are optional.

Investigation

The Board investigates all complaints in an objective, consistent and transparent manner. Each complaint is investigated on its own merit, and may result in a hearing before the Board. Following a hearing, the Board may, for cause, suspend, revoke or cancel a licence; reprimand and/or fine a licensee or permit holder; impose licence or permit conditions, or suspend, revoke or cancel a certificate of qualification.

In 2019, the Funeral Board of Manitoba:

- Received nine written complaints (seven pertained to *The Funeral Directors and Embalmers Act* and two to *The Prearranged Funeral Services Act*).
- Revoked one Certificate of Qualification, cancelled one Funeral Director and Embalmer Licence and issued a reprimand (hearing was held on November 19, 2018 and decision was pronounced on January 18, 2019)

Name: Chad Wheeler, license number 587 Reason: The Funeral Board of Manitoba found that Mr. Chad Wheeler had breached *The Prearranged Funeral Services Act*. By doing so, the Board determined that Mr. Wheeler also breached the Code of Ethics and therefore contravened *The Funeral Directors and Embalmers Act*.

- Imposed a fine and issued a reprimand to the following individual
 - Name: Rock Fontaine, Funeral Director licence number 438 and Embalmer licence number 412

- Reason: Following a hearing held on November 5, 2019, the Board found that Mr. Fontaine breached the Code of Ethics and therefore contravened *The Funeral Directors and Embalmers Act.*
- Issued a reprimand to the following individual
 - Name: Robert Gregory Emerson (In 2017, Funeral Director/Embalmer licence # 1246 was suspended)
 - Reason: Following a hearing held on November 5, 2019, the Board found that Mr. Robert Gregory Emerson breached the Code of Ethics and *The Funeral Directors and Embalmers Act.*

In addition, the Funeral Board of Manitoba completed investigation of ten complaints ongoing from the previous year (2018), of which four involved no breach, four were referred to another authority, one was referred to a hearing that occurred in 2019, and one remained ongoing in 2019.

The Public Interest Disclosure (Whistleblower Protection) Act came into effect in April 2007. This law gives employees a clear process for disclosing concerns about significant and serious matters (wrongdoing) in the Manitoba public service, and strengthens protection from reprisal. The Act builds on protections already in place under other statutes, as well as collective bargaining rights, policies, practices and processes in the Manitoba public service.

Wrongdoing under the Act may be: contravention of federal or provincial legislation; an act or omission that endangers public safety, public health or the environment; gross mismanagement; or, knowingly directing or counseling a person to commit a wrongdoing. The Act is not intended to deal with routine operational or administrative matters.

A disclosure made by an employee in good faith, in accordance with the Act, and with a reasonable belief that wrongdoing has been or is about to be committed is considered to be a disclosure under the Act, whether or not the subject matter constitutes wrongdoing. All disclosures receive careful and thorough review to determine if action is required under the Act, and must be reported in a department's annual report in accordance with Section 29.1 of the Act.

The Funeral Board of Manitoba received no disclosures under the Act in this calendar year.

INDEPENDENT AUDITOR'S REPORT

To the Legislative Assembly of Manitoba To the Board of Directors of the Funeral Board of Manitoba

Opinion

We have audited the financial statements of the Funeral Board of Manitoba (the Board), which comprise the statement of financial position as at December 31, 2019, and the statement of operations, the statement of changes in net financial assets and the statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of the Board as at December 31, 2019, and its operations, its changes in net financial assets and its cash flows for the year then ended in accordance with Canadian public sector accounting standards (PSAS).

Basis for Opinion

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Auditof the Financial Statements* section of our report. We are independent of the Board in accordance with the ethical requirements that are relevant to our audit of the financial statements in Canada, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Emphasis of Matter – Material Uncertainty Related to Going Concern

We draw attention to Note 9 in the financial statements, which indicates that the Board has been incurring deficits and drawing down on the accumulated surplus. As stated in Note 9, these events or conditions, along with other matters set forth in Note 9, indicate that a material uncertainty exists that may cast significant doubt on the Board's ability to continue as a going concern. Our opinion is not modified in respect of this matter.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with PSAS, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Board's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless an intention exists to liquidate the Board or to cease operations, or there is no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Board's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Canadian generally accepted auditing standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with Canadian generally accepted auditing standards, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design
 and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to
 provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for
 one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the
 override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Board's internal control.

THE FUNERAL BOARD OF MANITOBA NOTES TO FINANCIAL STATEMENTS FOR THE YEAR ENDED DECEMBER 31, 2019

1. Nature of Operations

The Funeral Directors and Embalmers Act established The Funeral Board of Manitoba (the Board) to licence and regulate Funeral Homes, Funeral Directors and Embalmers and to prescribe the courses of training and instruction for articling students. As at December 5, 2013 the Board has been assigned the responsibility to licence and regulate under The Cemeteries Act.

As at September 1, 2017 the Board has been assigned the responsibility to licence and regulate under The Prearranged Funeral Services Act.

2. Significant Accounting Policies:

a. Basis of accounting

These financial statements are prepared by management in accordance with Canadian public sector accounting standards established by the Canadian Public Sector Accounting Board.

b. Cash

Cash includes cash on hand and bank balances.

c. Investments

Investments consist of guaranteed investment certificate (GIC) with a national financial institution. The investment certificate is a flexible short term nature with a maturity of one year or less and cashable at any time.

d. Deferred Revenue and Revenue Recognition

The Board recognizes revenue under The Funeral Directors and Embalmers Act, The Cemeteries Act and The Prearranged Funeral Services Act on an accrual basis. Any license fees which are received prior to December 31 with respect to and are applicable to the subsequent fiscal year are recorded as deferred revenue. Grant revenue is recognized when it is authorized and any eligibility criteria have been met. Receivables are recognized by the Board for those grants authorized by the Province prior to the end of the accounting period but not received.

e. Expenses

Expenses are reported on an accrual basis. The cost of all goods consumed and services received during the year is expensed.

f Measurement uncertainty

The preparation of financial statements in conformity with Canadian public sector accounting standards, requires management to make estimates and assumptions that affect the reporting amounts of assets and liabilities at the date of the financial statements and the reported amounts of the revenues and expenses during the period.

Estimates are based on the best information available at the time of preparation of the financial statements and are reviewed annually to reflect new information as it becomes available. Measurement uncertainty exists in these financial statements. Actual results could differ from these estimates.

g. Non-Financial Assets

Tangible capital assets and other non-financial assets do not normally provide resources to discharge liabilities of the Board. These assets are normally employed to provide future services.

Tangible capital assets are recorded at cost. Cost includes the purchase price as well as other acquisition costs. The costs of tangible capital assets are amortized over their estimated useful lives as follows:

> Rate Method 20% Straight line

Computer equipment 20% Straight lin One-half of the annual amortization is charged in the year of the acquisition and in the year of disposal.

Financial instruments are classified into one of the two measurement categories: (a) fair value; or (b) cost or amortized cost.

The Funeral Board of Manitoba (the Board) records its financial assets at cost, which includes cash, short term investments and accounts receivable.

The Board also records its financial liabilities at cost, which includes accounts payable and accrued liabilities.

3. Financial instruments and Financial Risk Management - continued

Gains and losses on financial instruments measured at fair value are recorded in accumulated deficit as re-measurement gains and losses until realized. Upon disposition of the financial instruments, the cumulative re-measurement gains and losses are reclassified to the statement of operations. Gains and losses on financial instruments measured at cost or amortized cost are recognized in the statement of operations in the period the gain or loss occurs.

The Board did not incur any re-measurement gains and losses during the year (2018 - \$ nil).

Financial Risk Management - overviews

The Board has exposure to the following risks from its use of financial instruments: credit risk; liquidity risk; market risk; interest risk; and foreign currency risk.

Credit Risk

Credit risk is the risk that one party to a financial instrument fails to discharge an obligation and causes financial loss to another party. Financial instruments which potentially subject the Board to credit risk consist principally of cash, short term investments and accounts receivable.

Cash and Short Term Investments: the Board is not exposed to significant credit risk as these amounts are held by a Canadian Chartered Bank.

Accounts Receivable: the Board is not exposed to significant credit risk as accounts receivable are from the Vital Statistics Agency, a provincial government organization. Accounts receivable are neither past due or impaired.

Liquidity Risk

Liquidity risk is the risk that the Board will not be able to meet its financial obligations as they come due. The Board manages liquidity risk by maintaining adequate cash balances.

Market Risk

Market risk is the risk that changes in market prices, such as interest rates and foreign exchange rates, will affect the Board's income or the fair value of its financial instruments.

Interest Rate Risk

Interest rate risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market interest rates. The interest rate exposure relates to cash.

The interest rate risk on funds on cash is considered to be low because of their short-term nature.

Foreign Currency Risk

Foreign currency risk is the risk that the fair value of future cash flows of a financial instrument will fluctuate because of changes in foreign exchange rates. The Board is not exposed to significant foreign currency risk as it does not have any financial instruments denominated in foreign currency.
