  - d. Continuity schedule of plots available for sale at the beginning of the period, plots sold  
 during the period, additional plots acquired and plots available for sale at the end of  
 the period;
  - e. A confirmation from the Trustee of fund assets held (fair market value and book  
 value) as well as amounts received and distributed during the period under  
 examination;
  - f. Schedule detailing the allocation of total expenses between perpetual care and the  
 other business interest of the cemetery;
  - g. Budget for the next two or three years of future operations related to perpetual care;
  - h. Comparisons of actual versus budgeted operations for year under review, with  
 explanations for significant variances from budget and prior year
