Introduction

The Department of Labour, Consumer Protection and Government Services (LCPGS) is a newly created and dynamic department that provides services to departments and organization within the Manitoba Public Service, as well as the broader public sector. The Digital and Technology Solutions (DTS) Division is the Manitoba's central IT team providing information and technology solutions to support government programs and services. DTS is undergoing a transformation centred on collaboration, information and technology leadership, security, and a whole-of-government approach to enable government departments to provide valuable services to citizens and businesses in a financially responsible, efficient, secure and timely manner. We provide the IT products and services used by both the public and the Public Service while ensuring Manitoban's data remains protected and secure. DTS plays a key role in IT investment decisions and has functional accountability for entire life-cycle of Manitoba's IT portfolio, including strategy and roadmap management, implementation, ongoing support, and sun setting. DTS' portfolio of solutions include public facing applications, internal support tools, technology infrastructure, end user equipment and client support services (ITSM help desk). DTS' Executive Management team will play a key role in establishing and fostering the culture necessary to refine and deliver the strategy and IT solutions our clients require to deliver the services Manitoban's need.

Position Overview

<u>Executive Director, Applications Delivery and Support</u>

The Applications Delivery and Support Branch, through its Project Management Office, is accountable for managing the delivery of new applications and application enhancements. The team collaborates with other functional areas of DTS as well as department stakeholders and applies disciplined projects management practices to ensure projects execution supports desired business outcomes while remaining within the predefined constraints and strategies. This branch continues to support the applications throughout the remainder of their lifecycle including application maintenance, administration, configuration, and client second level support.

Executive Director, Business Management

The Business Management Branch is directly responsible for DTS' business operational and day-to-day activities as well as the customer's value proposition. This Branch ensures the Division is operating effectively as a services-based, business oriented and value focused service provider. The Business Management Branch's key is responsible for the Division's financial management, strategic sourcing, talent management, business performance management and the office administration.

Executive Director, Client Services and Infrastructure

The Client Services and Infrastructure Branch is responsible for supporting the design, transformation and growth of service availability and support. This branch continuously enhances the end-to-end customer experience and collaborates with other branches and IT functions to improve service performance, scalability and reliability. This area is responsible for the technology operations centre, change and incident management, and customer first level support functions. This area also supports enduser equipment/devices, enterprise-wide collaboration and productivity tools and well as the critical communications and storage infrastructure.

Executive Director, Technology and Product Strategy

The Technology and Product Strategy Branch is accountable for driving the development of a cohesive technology and product strategy for DTS. The strategy is realized through collaboration with the other branches within DTS. The branch is responsible for setting technology standards and policies, selecting and approving technology, and converting the technology solutions into products and product portfolios including the development of business models and product SLAs. The branch is also responsible leading the Enterprise Architecture and the business relationship management practices.

Executive Director, Transformation Projects

This Branch is responsible for the planning and implementation of projects that are multi-year in nature and that have significant impacts across the Manitoba government. Projects of this scale and complexity often involve stakeholders and impacts to summary government and Crowns. This area delivers on projects that have a whole of government impact that frequently have complex funding, governance and decision making models. Currently this branch is leading Manitoba's ERP/SAP modernization project which will transform government's most critical operating processes for financial, procurement, asset management and HR business functions.

The Executive Directors will:

- Lead the development of strategic objectives, financial and business plans, and operating principles that are consistent with government direction, department goals and public expectations; evaluate outcomes and ensure all legal and reporting requirements are met
- Direct the management of the human and financial resources for the Branch to deliver on operational and strategic mandates, ensuring the appropriate allocation of resources to maximize efficiency
- Develop relationships with internal, cross department and external stakeholders and lead cross-department and corporate initiatives
- Manage significant and complex vendor contracts including their establishment, ongoing performance management, and relationship management
- Support the Assistant Deputy Minister by providing strategic options, comprehensive policy advice and recommendations using internal and external expertise
- Provide effective briefings and advice to the Senior Leaders and Clients
- Lead the implementation of Manitoba's digital and technology solutions strategy and portfolio by establishing and leading the appropriate governance, transparency, communication plan, and reporting structures to ensure project delivery align with department and government outcomes while innovating and prioritizing to meet schedule and financial constraints
- Build a respectful workplace culture that promotes diversity, learning and continuous improvement
- Coach and mentor the Branch management team and support individual and team development
- Provide leadership and support in addressing organizational resilience
