

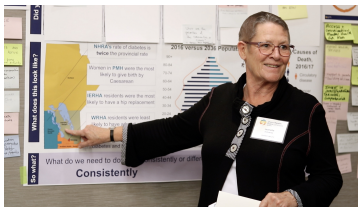
On September 14, 2018 work began on the development of a Provincial Clinical and Preventive Services Plan for Manitoba.

The first Provincial Clinical and Preventive Services Plan (PCPSP) Visioning Session brought together clinical experts and front-line providers from across the province.

Provincial Clinical Team (PCT) members met to collaborate with colleagues from across the province, gaining a shared understanding of the current state of Manitoba's health care system and the need to transform our system to a more integrated and coordinated model.



PCPSP Project Lead Lanette Siragusa laid the foundation for the process ahead, emphasizing the opportunity it presents to recommend and implement the changes that many health care professionals in Manitoba have pushed for throughout their careers, some for nearly 20 years.



Participants explored the current state of health care in Manitoba and reflected upon key events that have shaped the evolution of how we deliver care. PCT members discussed what we are doing well and began to identify the areas that must fundamentally change if outcomes are to improve in the future.



Clear pathways and seamless transitions between health services and healthcare providers will ensure patients are able to receive the care they need, when they need it, from the most appropriate health care professional, and as close to home as possible.



Health care options must evolve as the needs of patients, the leading practices and available technology change. This process will look closely at not only what we could be doing differently and better, but also at what we should no longer be doing at all.

What comes next?

We are creating a system where patients will be able to easily navigate health services and quickly access the care they need. A phased approach to the development of a Provincial Clinical and Preventive Services Plan will ensure we are able to work collaboratively throughout this journey, ensuring the involvement of provincial stakeholders and a consistent focus on the voice of the patient throughout planning, design and implementation.

Phase 1 (July – August 2018) involved the establishment of governance and design principles as well as significant gathering and analysis of Manitoba data. Initial stakeholder engagement efforts began in this phase and two PCTs – Emergency, Critical Care & Acute Medicine and Primary Health & Community Services – got an early start and began reviewing the data compiled on the current state of their specialty areas as well as the models of care and practices compiled from other jurisdictions.



Phase 2 (September 2018)

This phase includes a focus on provincial visioning. PCTs were brought together to prepare for the journey ahead. Teams were provided with an overview of the principles guiding planning discussions and decisions as well as the process by which recommendations from each of the 11 provincial clinical teams will be integrated into one Provincial Clinical and Preventive Services Plan.

Principles guide our planning discussions and decisions



Phase 3 (September 2018 – March 2019) will see each PCT provided with the data compiled on the services, delivery and models of care included in the current state of their specialty areas. Teams will receive jurisdictional analyses of the models of care and practices used in other places and will discuss how learnings from away could apply to specific issues and challenges in Manitoba's current state. These discussions will result in initial future state models or "prototypes", which will include draft standards, pathways, consideration of specialized populations and proposed means of evaluation.

A provincial clinical symposium in December will ensure teams work collaboratively to identify key enablers and areas of interdependency. Additional workshops will ensure integration across all PCTs as future state models or "prototypes" are finalized.

Phase 4 (March – May 2018) – The final phase of planning will include a focus on implementation. Future State Models will be refined and integration across the planning teams will occur as a PCPSP roadmap is completed for the implementation of the Provincial Clinical and Preventive Services Plan.
