2024/25	Major	A resident experienced a change in their medical condition. The opportunity for earlier recognition and intervention was not realized.
2024/25	Death	A patient experienced a delay in diagnosis and treatment of an acute medical condition requiring a transfer to a higher level of care.
2024/25	Major	A patient experienced skin tissue breakdown requiring increased care and intervention. Opportunities to provide earlier intervention were not consistently realized.
2024/25	Major	Gaps in services resulted in a client's change in health status and unplanned admission to hospital.
2024/25	Major	A patient experienced a delay in diagnosis and treatment of an acute medical condition resulting in an adverse outcome and transfer to a higher level of care.
2024/25	Major	A patient experienced skin tissue breakdown requiring increased care and intervention. Early opportunities to provide intervention were not consistently realized.
2024/25	Major	A resident experienced skin tissue breakdown related to a medical device requiring increased care and intervention.
2024/25	Major	The process for surgical preparation and informed consent did not consistently follow standard procedure.
2024/25	Death	Opportunities for community collaboration during pre-hospital care were not realized.
2024/25	Major	An infant was born with an infection. Opportunities for earlier treatment were not recognized.
2024/25	Major	A patient experienced a fall resulting in serious injury. Early opportunities to mitigate risks were not realized.
2024/25	Major	A patient experienced a delay in treatment for an acute medical condition which resulted in the need for a higher level of care.
2024/25	Major	A missed opportunity to respond to a laboratory result led to a delay in treatment of an acute medical condition requiring transfer to a higher level of care.
2024/25	Major	A patient experienced a procedural complication requiring emergent intervention.
2024/25	Major	Gaps in risk mitigation and prevention strategies contributed to deterioration of a pressure injury.
2024/25	Death	Delayed investigative results led to delayed interventions and transfer to higher level of care.
2024/25	Major	Client sustained serious burns.
2024/25	Major	After a surgical procedure, it was recognized that the patient experienced a retained foreign item that resulted in infection and required removal.
2024/25	Death	A patient experienced a medical emergency and attempts to transfer the patient to a tertiary care centre for treatment were unsuccessful.
2024/25	Major	A patient experienced acute deterioration as a result of a medical device issue.
2024/25	Major	A resident experienced skin tissue breakdown related to a medical device requiring increased care and intervention. Opportunities for earlier intervention were not consistently realized.

2024/25	Major	Gaps in risk mitigation and prevention strategies contributed to a patient developing a pressure related skin injury.
2024/25	Major	Patient experienced elevated drug levels resulting in harm.
2024/25	Major	Patient experienced elevated drug levels resulting in harm.
2024/25	Major	A resident developed a Stage 3 pressure injury while in care.
2024/25	Major	Gaps in assessment and monitoring led to an acute change in the patient's condition.
2024/25	Death	A patient experienced a delay in transfer to a higher level of care for treatment of an acute medical condition.
2024/25	Major	A patient experienced a delay in treatment, leading to an escalation of care.
2024/25	Major	An opportunity for earlier diagnosis and intervention was not realized. The patient deteriorated and required a higher level of care.
2024/25	Major	A patient experienced an acute change in their medical condition. Opportunities for earlier assessment and intervention was not realized.
2024/25	Death	A patient experienced a change in their medical condition. The opportunity for earlier consultation and treatment was not realized.
2024/25	Death	There were gaps in monitoring and assessment. Missed opportunities to recognize and provide treatment for an acute medical condition were identified.
2024/25	Death	A missed opportunity for earlier interventions resulted in clinical deterioration.
2024/25	Major	A patient experienced a delay in diagnosis of an acute medical condition.
