## **Re: Manitoba's 2020/21 Seasonal Influenza/Pneu-P-23 Immunization Program**

Immunization against influenza (flu) is recommended for all Manitobans 6 months of age and older. Although influenza immunization is recommended every year, it is anticipated that COVID-19 and the flu will be co-circulating in the coming months. It is critical that those at increased risk of serious illness from the flu, their caregivers and close contacts be immunized against influenza to prevent influenza-like illness and its potential complications.

Consistent with previous years, Manitobans turning 65 years of age will be receiving a letter in early October 2020 advising them of their eligibility for the Pneu-P-23 vaccine. In past years, those turning 65 years who had previously received a Pneu-P-23 vaccine were excluded from the mail out. This year, **all Manitobans** turning 65 years of age will be getting a letter. Patients who have had a previous Pneu-P-23 dose before their 65<sup>th</sup> birthday (e.g., under high-risk eligibility) are eligible to receive a second dose, provided there is a 5 year minimum interval between Pneu-P-23 doses. In light of the COVID-19 pandemic and physical distancing impact on influenza community clinics, the National Advisory Committee on Immunization (NACI) reviewed the evidence around the recommended observation period post vaccination. NACI concluded that there was no evidence to support a decrease from the current 15 minute observation period and therefore, MHSAL recommends continuing this practice.   - Residents of supportive and assisted living housing, OR
  - Clients in interim/transitional care beds, respite care clients as well as new, unimmunized residents admitted to a LTCF during the flu season, OR
  - In a provincial correctional facility, including those who are newly incarcerated or transferred from other federal or out of province correctional facilities, OR
  - Receiving homecare services while on a waiting list for admission into a LTCF, OR
  - Living on a First Nation or remote/isolated community, OR
  - Living north of the 53rd parallel of latitude.

**Note:** all administered doses of Fluzone® High-Dose must be recorded in the Manitoba Immunization Registry using **tariff code 8775**; all other publicly-funded, doses should be entered using tariff code 8791.

The province is starting to receive some of its seasonal influenza vaccine shipment. Please continue to monitor the *Seasonal Flu Vaccine Distribution and Supply* webpage at [www.manitoba.ca/fludistribution](http://www.manitoba.ca/fludistribution) for updates.
