2014: **94**/175 deaths (54%) 2015: **85**/182 deaths (47%) 2016: **88**/173 deaths (51%) 2017: **106**/192 deaths (55%) 2018*: **32** opioid-related deaths

The "increasing" and "decreasing" trends indicated by the arrows (\downarrow / \uparrow) refer to the change from updated 2018 first quarter numbers.

Across the country, opioid use and overdose continues to have devastating effects on families and communities. Manitoba Health, Seniors and Active Living (MHSAL) has been working closely with partners since the beginning of 2017, to collect and share data with stakeholders and to monitor trends related to opioid use and overdose, in addition to harms and response efforts. A number of changing trends were identified this quarter:

- An increase in the number of individuals suspected to have overdosed on opioids and administered naloxone by EMS personnel in Winnipeg;
- An increase in the distribution of Take Home Naloxone Kits to individuals;
- Self-reported poly drug use across quarterly reporting periods is varying, with an increase noted between the first and second quarter; and
- Consistent reporting (since August 2018) of preliminary reports of carfentanil in toxicology casework.

The Epidemiology and Surveillance unit of the MHSAL will continue to monitor these changing trends as additional information becomes available, and continue to work closely with regional, provincial, and national stakeholders to improve prescription opioid monitoring, public awareness and education, prevention and harm reduction, and mental health and addiction treatment services.
