Income Verification

In order to determine tenant eligibility, landlords require information regarding the household income from all tenants residing in an affordable rental unit. Household Income - Total income (before tax) from all sources for all persons in the household 18 years of age and over.

Total gross household income shall be calculated by using Line 150; Total Income on the T1 General Income Tax Form, less Line 117; Universal Child Care Benefit (UCCB). The gross household income will be further reduced by the Disability Tax Credit (DTC) when applicable. Other sources of income, such as Canada Child Tax Benefit (CCTB) and Goods and Services Tax (GST) Credit are not to be used when calculating the total household income for eligibility purposes.

- If the tenant is self-employed, the above calculation for the most recent year's Income Tax will be used, plus the average of the three most recent years Business Activities.
- If the household income has changed since the most recent year's Income Tax, the average of three recent pay-stubs will be used to calculate an estimated gross annual income. If applicable, this amount will be reduced by the DTC from the most recent year's Income Tax.

Household income must be at or below the Program Income Limit, to be eligible for an affordable rental unit.
