HOW TO CHECK IF CLIENT EXIST IN iMaQS

A business or an individual that has done transactions with Mines Branch may already have a profile in iMaQs.

To maintain the data integrity of iMaQs and avoid creating a duplicate record for the same business or individual, it is important to verify if a profile is already setup in iMaQs.

CHECK #1: DOES YOUR PRIMARY CONTACT PERSON EXIST IN IMAQS?

How to check?

To determine if your name already exist in iMaQs, please do the following:

- 1. Go to https://web33.gov.mb.ca/imaqs/
- 2. Do either a Mining or a Quarry Search. (Note: You don't have to login into iMaQs to do a search)

3. Click on either Mining Search or Quarry Search



4. The Search Parameter page will open. Go to the Holder Name field.

5. Enter the Holder Name. Enter a partial name to have more results. Let's say you are John Smith. Enter **John%** with the **percent symbol (%)** for a wildcard search. This way all the clients with **JOHN** in either in their First Name or Last Name will populate in the search result.
