## PIPELINE OPERATING LICENCE NO. 2013-07A

# PIPELINE from 09-32-01-28 WPM to 14-36-01-28 WPM

# LEGACY OIL + GAS INC. AND CRESCENT POINT ENERGY CORP.

WHEREAS, Legacy Oil + Gas Inc. was granted operating licence under Section 152 of The Oil and Gas Act ('the Act") for crude oil pipeline from 09-32-01-28 WPM to 14-36-01-28 WPM.

**AND WHEREAS,** on May 26, 2015, Crescent Point Energy Corp. has purchased the pipeline and made application under Section 158 of the Act for authorization to transfer the Pipeline Operating Permit 2013-07.

AND WHEREAS, Subsection 158 of the Act provides as follows:

158 Subject to Subsection 100(3), a licence or permit issued under this Part may be transferred in accordance with the regulations.

**AND WHEREAS**, the Minister is satisfied that the application to transfer is complete and that TEML is registered under the Corporations Act.

**NOW, THEREFORE,** the Minister approves the transfer and continued operation of the pipeline in accordance with the following terms and conditions:

- The Licencee shall operate and maintain the pipelines in accordance with the Act, this license, CSA Standard Z662-15 Oil and Gas Pipeline Systems and the procedures contained in the Crescent Point Energy Corp. Operations Manual, all as amended from time to time.
- 2. The maximum operating pressures ("MOP") of the pipeline shall be12,000 kPa. The MOP of the pipelines may be varied by the Director.

- 3. The Licencee shall provide the Director with a copy of the pipeline tariff schedules and shall advise the Director in writing of any changes in the tariff schedules.
- 4. The Licencee shall not make modifications to the pipelines without the approval of the Minister obtained in accordance with Section 150 of the Act. The Minister's authority under Section 150 of the Act is delegated to the Director pursuant to Order in Council 384/2001.
- 5. The Licencee shall maintain membership in the Manitoba Producers Oil Spill Cooperative.
- 6. The Licencee shall provide the Director with an annual report on pipeline operations pursuant to Subsection 152(4) of the Act. The annual pipeline report shall include details of:
  - (a) volumes of oil transported each month;
  - (b) any leaks, breaks or contact damage;
  - (c) any major modifications, maintenance or repairs;
  - (d) digital location (in a compatible format to the Director) of the pipelines in the first reporting year and updates in subsequent reports thereafter;
  - (e) any changes to the tariff schedule; and
  - (f) any other information requested by the Director.

Each annual report shall be filed with the Director of the Petroleum Branch in a compatible format no later than sixty (60) days after the end of each calendar year.

- 7. The Licencee shall comply with all terms and conditions of the original licence.
- 8. The Licencee shall register a plan of the pipelines in the appropriate Land Titles Office.
- The Licencee shall provide the Director with a copy of the TEML Operating and Maintenance Manual.
- 10. The Minister may amend the terms and conditions of this licence as the Minister deems necessary or advisable to meeting changing conditions.

- 11. Pipeline Operating Licence 2013-07 has been revoked.
- 12. This licence shall continue until revoked by the Minister.
