## **INFORMATIONAL NOTICE 11-04**

## Manitoba Email Notification System for Drilling, Well Servicing and Facility Construction Operations

In order to streamline the well operation notification system, the Manitoba Petroleum Branch is introducing an email system to replace the previous phone message notifications. The email notification will be effective immediately addressing all regulated notifications for drilling, well servicing and facility construction operations.

As per Drilling and Production Regulation 111/94 the regulated notifications are:

18 The licensee shall give notice to the district office as follows:

- (a) not less than 24 hours before commencement of wellsite construction;
- (a.1) not less than 24 hours before spudding a well;
- (b) not less than two hours before pulling pipe during a drill stem test;
- (c) not less than two hours before cementing casing;
- (d) not less than one hour before completing or servicing a well;
- (e) not less than 24 hours before conducting a pressure test under subsection 50 (1);
- (f) not less than 24 hours before commencing a segregation test under subsection 52 (3);
- (g) not less than two hours before commencing the abandonment of a well in which only surface casing has been run;
- (h) not less than 24 hours before commencing the abandonment of a well in which production casing has been run;
- (i) not less than two hours before backfilling an abandoned well.
- 91 The licensee shall give notice to the district office as follows:
  - (a) not less than 24 hours before commencing construction, pressure testing, suspension, reactivation, or abandonment of a flowline;
  - (b) not less than one hour before commencing the repair of a flowline.

The subject line must include the WELL LICENCE, OIL COMPANY, LOCATION OF JOB AND TYPE OF OPERATION
