

# **INFORMATIONAL NOTICE 20-05**

# **REPORTING DEADLINES**

Manitoba Oil and Gas Act

In accordance with The Oil and Gas Act, Drilling and Production Regulation, The Oil and Gas Production Tax Act and Oil and Gas Production Tax Act Regulation, Manitoba's oil and gas operators are required to report volumetric, valuation, and infrastructure data to the Petroleum Branch. As of May 2020 reporting deadlines for oil and gas activities in Manitoba are changing with the implementation of Petrinex. This notice outlines the important changes to Manitoba's reporting deadlines.

Beginning in April 2020, volumetric, valuation, and some infrastructure data will be reported using information the industry enters into Petrinex. As a result, the following reporting deadlines for the submission of Manitoba data to Petrinex will change:

- Volumetric Reporting Deadline
- Pipeline Split Reporting Deadline
- Valuation Reporting Deadline
- Infrastructure Reporting Deadline

## **Volumetric Reporting Deadline**

All operators are to enter volumetric information into Petrinex after the end of the production month. Operators are to make sure volumetric data is **complete** and **balanced** prior to the volumetric reporting deadline on or before the 21<sup>st</sup> day of the calendar month following the production month.

## **Pipeline Split Reporting Deadline**

All operators are to enter pipeline split information into Petrinex after the end of the production month. Operators are to make sure pipeline split data is **complete** and **balanced** prior to the pipeline split reporting deadline on or before the 21<sup>st</sup> day of the calendar month following the production month.



## **Valuation Reporting Deadline**

Producers and purchasers of oil and by-products are to enter valuation and pricing data into Petrinex on or before the 29<sup>th</sup> day of the calendar month following the production month.

## Infrastructure Reporting Deadline

Operators of wells and/or facilities must obtain an appropriate facility ID through Petrinex on or before the volumetric reporting deadline.
