I am pleased to provide you the 2013 Aboriginal and Northern Affairs Capital Approval Board Report. The board convened at the Viscount Gort, Winnipeg, Manitoba on September 17 & 18, 2013.

This report includes:

The 2013 Capital Approval Board is recommending projects in category 2 maintaining/replace existing and category 3 new infrastructure totalling \$2,101,281.00 from a possible allocation of \$3,000,000.00 leaving a variance of \$898,719.00.

Due to a low volume of recommended applications in 2012 the Capital Approval Board did not convene. However, legislative projects were approved internally for delivery in 2014/2015 and 2015/2016 respectively and are included in this report.

It was determined in 2012 that categories 2 & 3, maintaining/replace existing and new infrastructure would no longer be approved two years in advance, but rather one year in advance with category 1, legislative remaining as a two year advance approval.

In closing, I would like to thank you for the opportunity to work with the board members and departmental staff.

Minutes
September 17 & 18, 2013
Viscount Gort, Winnipeg, MB

The meeting was called to order at 9:00am.

1. The following resource material was reviewed with board members by departmental staff:
 1. Agenda
 2. Departmental Vision and Mission
 3. Capital Program Policy
 - Board Principles
 - Project Criteria
 - Building Funding Principles
 - Surplus Funding and Carry Over Funding Principles
 4. Definition of Municipal Services
 5. Vehicle Replacement Policy

 6. Guidelines for Community Municipal Infrastructure
 7. Project Assessment Form
 8. Allocation of funds for 2014/2015
 9. Recommendations for Continuous Improvement
2. The Departmental Five-Year Capital Plan was presented by Albert Sandberg.
3. Board members agreed to using a sliding scale (0, 5, 10, 15) for questions found in the Need portion of the Project Assessment Form. The Board also agreed to a sliding scale (0, 5, 10, 15, 20, 25) for the question, “how critical is this project”.
4. The Board agreed that a group rating method would be followed and decisions would be determined by a consensus of the members. If consensus could not be reached, a second democratic vote would occur.
5. Board members were advised that to avoid conflict of interest issues, board members can be present for project presentation but must leave the room for the project assessment rating if the project is from their home community.

6. The Board assessed all projects submitted utilizing the project assessment form provided. Recommendations were made based on the completeness of applications, available funding and those applications which received a score of 40 points or better.

7. Armand Barbeau, Director, Northern Region, requested the board consider a community hall project in Pelican Rapids which did not fall within the Capital Approval Board process. The application was not submitted by the May deadline, was not subject to pre-screening and was not present in the capital binders for presentation. The application was not submitted due to a fire May 5, 2013. However the board determined, based upon the verbal presentation to recommend the project at \$400,000.0 for delivery in 2014/2015.

8. The Board provided the following recommendations for continuous improvement for the Department to consider:

- Service areas defined for vehicle replacement guidelines – how is this defined? Clarify in the policy/application/assessment sheet – provide justification, have other options.
- Make the department's role in the ranking clear – is it the director or technical staff, or perhaps two members from that region?
- The department look at vehicle costs to ensure they are reflective of current values.
- More information be provided regarding what constitutes a prior commitment.
- All environmental orders/issues should be brought to the board.
- Project assessment – sustainability of the project, please review and revise.
- Project assessment - is there an internal/external document for this project, please provide more clarity?
- Project assessment – emergency, please clarify.
- Project assessment - is it well planned? – please provide more clarity.
- Project assessment – need, legal opinions. Is this required; perhaps keep only the last bullet?
- Greater flexibility in assessing projects at the regional level and at the CAB – the board would like the option of moving something along though missing information.
- All applications that come to CAB must be screened and not removed.
- Perhaps remove the pre-screening process all together. Look at having one pre-screening including all representatives. Joint pre-screening as opposed to what exists – have chair present at pre-screening.
- Communities should have more time to adjust applications in regards to financing.
- Letters that went to communities after first intake should be attached the pre-screening application.
- Provide binders to board prior to meeting (1 or 2 days) in advance.
- Include census data in the process manual from past years.
- Stagger board member terms.
- Look at more time for CAB meetings (3 or more days).
- Communities would like a letter sent to communities when their project application has been screened out or successful at the CAB.
- What constitutes a conflict of interest, definition or how it applies to CAB?
Ranking and conflict of interest, why must we be removed from the room?

8. The meeting was adjourned at 5:00 pm on September 18, 2013.
