26 has discretion either to dismiss the application for, for
27 the applicant's failure to attend or to adjourn it to the

30 this court to, to grant one adjournment when there's a
31 failure to attend at the first appearance but, again, that
32 is up to the court's discretion.

33 THE COURT: I look for, to Mr. McKenna --

34 MR. MCKENNA: Thank you, Your Honour.

1 THE COURT: -- because I have reviewed the
2 materials.

3 MR. MCKENNA: Yes. It's, it is quite accurate
4 that in many cases there are such adjournments on a first
5 time. I can tell you that before leaving to come here I
6 checked my voicemail and I checked my e-mails and I, or,
7 and I received no notice whatsoever from Mr. [REDACTED] that he
8 would be having a problem attending. He is a multiple
9 complainant and is very familiar with the system. And in
10 these particular circumstances, on that basis I'm asking
11 that the matter be dismissed, Your Honour.

12 THE COURT: Okay. I'm assuming that you also
13 want a publication ban though before I do so?

14 MR. MCKENNA: I do, Your Honour. Thank you very
15 much.

16 THE COURT: Okay. And I have had an opportunity
17 to review the materials and given that Mr. [REDACTED] isn't
18 here and given the, the nature of the materials I am going
19 to be dismissing the application.
