





***The cost disease : why computers get cheaper and health care doesn't*** / William J. Baumol ; with contributions by David de Ferranti ... [et al.]. New Haven, Conn. : Yale University Press, c2012. xxi, 249 p.

From **Yale University**:


The exploding cost of health care in the United States is a source of widespread alarm. Similarly, the upward spiral of college tuition fees is cause for serious concern. [...] Baumol explores the causes of these seemingly intractable problems and offers a surprisingly simple explanation. [...]

Baumol presents his analysis with characteristic clarity, tracing the fast-rising prices of health care and education in the United States and other major industrial nations, then examining the underlying causes, which have to do with the nature of providing labor-intensive services. The news is good, Baumol reassures us, because the nature of the disease is such that society will be able to afford the rising costs.

***Arming and disarming : a history of gun control in Canada*** / R. Blake Brown. Toronto : Published for the Osgoode Society for Canadian Legal History by University of Toronto Press, c2012. xvi, 349 p.

From the École Polytechnique shootings of 1989 to the political controversy surrounding the elimination of the federal long-gun registry, the issue of gun control has been a subject of fierce debate in Canada. But in fact, firearm regulation has been a sharply contested issue in the country since Confederation. *Arming and Disarming* offers the first comprehensive history of gun control in Canada from the colonial period to the present.





In this sweeping, immersive book, R. Blake Brown outlines efforts to regulate the use of guns by young people, punish the misuse of arms, impose licensing regimes, and create firearm registries. Brown also challenges many popular assumptions about Canadian history, suggesting that gun ownership was far from universal during much of the colonial period, and that many nineteenth century lawyers – including John A. Macdonald – believed in a limited right to bear arms.

*Arming and Disarming* provides a careful exploration of how social, economic, cultural, legal, and constitutional concerns shaped gun legislation and its implementation, as well as how these factors defined Canada's historical and contemporary 'gun culture.'

Jeanne Martinson gets to the heart of the generational differences issue, with minimal psychobabble and statistical navel gazing, giving you concrete information about the different generations with a focus on work ethic and the motivations and values of Generation Y.

So what happened?



In *The Big Shift*, John Ibbitson and Darrell Bricker argue that one of the world's most consensual countries is polarizing, with the west versus the east, suburban versus urban, immigrants versus old school, coffee drinkers versus consumers of energy drinks. The winners—in politics, in business, in life—will figure out where the people are and go there too.
