Mr. SVEINSON, Deputy Chairperson of the Committee of Supply presented the Report of the Proceedings of the Committee of May 31, 1999 as follows:

THREE HUNDRED DOLLARS for HOUSING: HOUSING EXECUTIVE \$253,300.00 for the fiscal year ending the 31st day of March, 2000. 30.2 RESOLVED that there be granted to HER MAJESTY a sum not exceeding FIVE MILLION, FOUR HUNDRED THIRTY-SEVEN THOUSAND, TWO HUNDRED DOLLARS for HOUSING: HOUSING PROGRAM SUPPORT \$5,437,200.00 for the fiscal year ending the 31st day of March, 2000. RESOLVED that there be granted to HER MAJESTY a sum not exceeding THIRTY-EIGHT MILLION, EIGHT HUNDRED SEVENTY-THREE THOUSAND, ONE HUNDRED **DOLLARS for HOUSING:** THE MANITOBA HOUSING AND RENEWAL CORPORATION..... \$38,873,100.00

for the fiscal year ending the 31st day of March, 2000.

RESOLVED that there be granted to HER MAJESTY a sum not exceeding FOUR 30.4 HUNDRED THIRTY-THREE THOUSAND, SIX HUNDRED DOLLARS for HOUSING:

AMORTIZATION OF CAPITAL ASSETS..... \$433,600.00

for the fiscal year ending the 31st day of March, 2000.

By unanimous consent, it was agreed that each section of the Committee of Supply would determine whether to adjourn at 5:00 p.m. or 6:00 p.m. for Tuesday, June 1, 1999, only.
By unanimous consent, it was agreed that all votes arising in the Committee of Supply, sitting inside the Chamber and in Room 255 and 254, for Tuesday, June 1, 1999 be deferred.
His Honour, PETER LIBA, Lieutenant Governor of the Province of Manitoba, having entered the House at 2:41 p.m., and being seated on the Throne:
Madam Speaker addressed His Honour in the following words:

The Legislative Assembly, at its present session, passed a Bill, which in the name of the Assembly, I present to Your Honour and to which Bill I respectfully request Your Honour's Assent:
