Hon. Mr. TOEWS presented:

Message from His Honour, the Lieutenant Governor recommending the disposition of public revenue for Bill (No. 34).

Following Oral Questions, Madam Speaker made the following ruling:

On May 31, 1999 I took under advisement a point of order raised by the Honourable Member for Kildonan respecting words used by the Honourable Minister of Health; the point of order was that the Minister had imputed unworthy motives.

Hansard shows that the Minister said, "it is typical desperation on their part to completely exaggerate, overstate, not come here with facts or whatever" and "to come to this House and try to scare people".

The comments did cause disorder, and I would caution the Minister when answering questions not to provoke debate. Strictly speaking, however, he did not impute unworthy motives to the Honourable Member for Kildonan.

I would also like to remind Members of the provisions of Beauchesne citation 468: in speaking to a point of order; the intervention must be confined to the point of order and must not refer to the general tenor of the debate. Members providing advice to the Chair as to whether a rule or practice of this House has been breached are to address the procedural point, not the issue under questioning or debate.
Pursuant to Rule 20 (1), Messrs. FAURSCHOU, ROBINSON, Mrs. DRIEDGER (Charleswood), Messrs. HICKES and SVEINSON made Members' Statements.
By unanimous consent, it was agreed to waive Private Members' Business for Monday, June 14, 1999 only.
By unanimous consent it was agreed that Thursday morning, June 17, 1999 would consist of two separate Private Members' Business hours.
By unanimous consent, the sequence for consideration of estimates, as outlined in Sessional Paper No. 110 tabled on May 11, 1999, and subsequently amended, was further amended in order that Sport be considered in the Chamber and Consumer and Corporate Affairs be considered in Room 255 for Monday, June 14, 1999, only.
Madam Speaker having left the Chair and the House resolving itself into a Committee to consider of the Supply to be granted to Her Majesty;
And the House continuing in Committee.
The House then adjourned at 6:00 p.m. until 1:30 p.m. tomorrow.
