RESOLVED that towards making good Certain Sums of Money granted to Her Majesty for the Public Service of the Province for the Fiscal Year ending the 31st day of March 2000, the sum of FIVE BILLION, FIVE HUNDRED FIFTY MILLION, ONE HUNDRED THIRTY-EIGHT THOUSAND, NINE HUNDRED DOLLARS (\$5,550,138,900.00), as set forth in Schedule A (Operating Expenditure) be granted out of the Consolidated Fund.
