## VOTES AND PROCEEDINGS No. 39

### FIRST SESSION, THIRTY-SEVENTH LEGISLATURE

**PRAYERS** 1:30 O'CLOCK P.M.

Immediately following Prayers, Mr. LAURENDEAU rose on a matter of privilege and moved:

THAT the termination of the audio broadcast by the Minister of Consumer and Corporate Affairs, the Minister of Northern and Aboriginal Affairs and the Minister of Highways and Government Services, of the Committee of Supply being held in the Chamber on Thursday, June 1, 2000, without any knowledge of the House or its Presiding Officer, is a contempt of this House;

THAT the Minister of Consumer and Corporate Affairs, the Minister of Northern and Aboriginal Affairs and the Minister of Highways and Government Services apologize to this House for their actions and the actions of their departments in bringing into question the dignity and honour of the House; and

THAT this matter be referred to the Standing Committee on Privileges and Elections for a complete review; and

THAT the Committee provide recommendations to the House for further action in order to prevent similar action from happening in the future.

And Hon. Mr. ASHTON, Mr. PRAZNIK and Hon. Mr. GERRARD having spoken,

WHEREUPON Mr. Speaker informed the House he would take the matter under advisement.
