

10:00 O'CLOCK A.M.

The Clerk formally advised the Assembly that Mr. Speaker was unavoidably absent and called upon the Deputy Speaker to take the Chair pursuant to the Statutes. The Deputy Speaker took the Chair at 10:00 a.m.

In accordance with Rule 31(9), the Opposition House Leader announced that the Improving the Standing Committee on Public Accounts Resolution will be considered next Thursday, June 17, 2010.

By leave, it was agreed for the House to deal with the debate on Second Reading of Bill (No. 204).

The House resumed the Interrupted Debate on the Proposed Motion of Mrs. MITCHELSON:

THAT Bill (No. 204) – The Child and Family Services Amendment Act/Loi modifiant la Loi sur les services à l'enfant et à la famille, be now read a Second Time and be referred to a Committee of this House.

And the debate continuing,

And Hon. Messrs. SWAN, GERRARD and BJORNSON, Mrs. STEFANSON, Hon. Ms. HOWARD, Mrs. TAILLIEU and Hon. Mr. CHOMIAK having spoken,

And Mr. REID speaking at 11:00 a.m. The debate was allowed to remain in his name and, by leave, in the name of Mr. DEWAR.

By leave, Mr. SCHULER moved an amended version of his proposed resolution:

Resolution No. 16: Youth for Christ Center: Supporting Winnipeg's Youth

WHEREAS both the City of Winnipeg and the Government of Canada have supported the Youth for Christ Youth Center of Excellence; and

WHEREAS Youth for Christ has a history of providing needed and highly accessed services for teens in Winnipeg and across Manitoba; and

WHEREAS the Provincial Government has provided funding to the Youth for Christ for various programs across Manitoba; and

WHEREAS recreational facilities and programs aimed at creating good role models for youth are a valuable tool for limiting gang recruitment and encouraging interest in education; and

WHEREAS membership in a gang encourages criminal behaviour and is harmful both to the youth who join gangs and to the city as a whole; and

WHEREAS Youth for Christ Youth Center of Excellence will offer an alternative to gangs and criminal activity for vulnerable inner city youth and will also rejuvenate downtown Winnipeg with its proposed building on the vacant land at Higgins and Main.

THEREFORE BE IT RESOLVED THAT the Legislative Assembly of Manitoba urge that the Provincial Government applaud the Youth for Christ Youth Center of Excellence and recognize this important initiative that offers an alternative to gang activity and an opportunity to revitalize Winnipeg's downtown.

Mrs. DRIEDGER – Legislative Assembly of Manitoba to request that the Provincial Government consider immediately providing Revlimid as a choice to patients with Multiple Myeloma and their health care providers in Manitoba through public funding. (B. Beach, J. Beach, M. MacDonald and others)

Mr. DERKACH – Legislative Assembly of Manitoba to request the Minister of Conservation to consider immediately placing the recent changes to the Onsite Wastewater Management System (OWMS) Regulation under *The Environment Act* on hold until such time that a review can take place to ensure that they are based on sound science and to consider implementing the prohibition on wastewater ejector systems on a case-by-case basis as determined by environmental need in ecologically sensitive areas and to consider offering financial incentives to help affected Manitoba property owners adapt to these regulatory changes. (M. Katchin, A. Cottington, D. Katchen and others)

Mr. GOERTZEN – Legislative Assembly of Manitoba to urge the Minister of Family Services to consider working with the Blumenort Christian Preschool to ensure that affordable nursery school options remain in the Blumenort community. (K. Plett, B. Plett, J. Plett and others)

Mr. SCHULER – Legislative Assembly of Manitoba to request that the Minister of Transportation consider the immediate installation of traffic signals at the intersection of PTH #15 and Highway #206 in Dugald and to recognize the value of the lives and well-being of the students and citizens of Manitoba.
