Resolution No. 19: Committing to an East-West Power Grid for Manitoba

WHEREAS the Manitoba New Democratic Party (NDP) has long been an advocate for an east-west power grid in Canada; and

WHEREAS the construction of an east-west electrical transmission connection in Manitoba would allow for the flow of new, clean hydroelectric power to other provincial markets; and

WHEREAS the former NDP Provincial Government was actively promoting the export of electricity, and engaging in discussions with the Federal and other Provincial Governments to encourage interprovincial sale of electricity; and

WHEREAS an east-west power grid would reduce greenhouse gas emissions in Manitoba and Canada and would help Manitoba contribute to national emissions reduction targets; and

WHEREAS the existing north-south power grid means Manitoba primarily exports surplus power to the U.S., while other provinces like Saskatchewan continue to burn coal to generate power; and

WHEREAS the Federal Government's national climate change plan will require innovative solutions and provides the opportunity for new initiatives which will meet the Canadian energy needs of the future.

THEREFORE BE IT RESOLVED that Legislative Assembly of Manitoba urge the Provincial Government to commit to partnering with the Federal and other Provincial Governments to create an eastwest power grid and to continue to pursue export opportunities for Manitoba's hydroelectric power.

Prior to Grievances, Hon. Mr. GERRARD rose on a Matter of Urgent Public Importance and moved:

THAT in accordance with Rule 38(1), the ordinary business of the House be set aside to discuss a Matter of Urgent Public Importance, namely, the need for urgent attention to the health of the Metis people in Manitoba and the need for measures which keep the Metis people healthy, and the urgent need for the government to act to support the Manitoba Metis Federation and the Metis people in their efforts to keep their people healthy.

And Hon. Messrs. GERRARD and MICKLEFIELD and Mr. MALOWAY having spoken to the urgency of the motion,

WHEREUPON Madam Speaker ruled as follows:

I thank Honourable Members for their advice to the Chair on whether the motion proposed by the Honourable Member for River Heights should be debated today.

I would note that notice of this matter required by Rule 38(1) was provided.

Under our rules and practices, the subject matter requiring urgent consideration must be so pressing that the public interest will suffer if the matter is not given immediate attention.

There must also be no other reasonable opportunities to raise the matter.

I do not doubt that this matter is one that is of serious concern to all members of the House, as I believe the health of the Metis people in Manitoba is a concern of all Members of this Legislature.

However I have listened very carefully to the arguments put forward, and I was not persuaded that the ordinary business of the House should be set aside to deal with this issue today.

I would note that there are other avenues for Members to raise this issue, including questions in Question Period, as well as raising the item as a Members' Statement.

Therefore, with the greatest of respect, I rule the motion out of order as a matter of urgent public importance.
