In accordance with Rule 33(8), the Opposition House Leader announced that the Private Member's Resolution titled "Immediate and Comprehensive Supports Needed for Manitoba Small Businesses" will be considered on the next Thursday of Private Members' Business.

Mr. ALTOMARE moved:

Resolution No. 3: Better Support for Schools, Teachers, Students and Families

WHEREAS the Pallister Government has for years underfunded schools in Manitoba and eliminated important programs that kept class sizes small; and

WHEREAS the Pallister Government failed to present a plan to invest in schools to ensure they can meet the challenges caused by the COVID-19 pandemic; and

WHEREAS the Pallister Government received over \$85 million dollars from the Federal Government to invest in schools but has refused to spend any of these funds in the schools; and

WHEREAS the Pallister Government has ignored calls from teachers, students, support staff, parents and other community groups to ensure class sizes remain small so that all students can safely and properly physically distance themselves in the classroom; and

WHEREAS the Pallister Government has refused calls to hire more teachers, support staff and educational assistants so that students can receive one on one attention and address learning loss that resulted from the closure of schools last spring; and

WHEREAS the Pallister Government did not provide any new supports so that schools and school divisions could prepare and acquire new classroom space, teaching and learning supplies and teaching areas; and

WHEREAS the Pallister Government instead interfered in ongoing negotiations at school divisions which precipitated a strike affecting transportation for many students and families; and

WHEREAS the Pallister Government failure to prepare an adequate back to school plan which has left teachers, educational assistants, support staff and school administrators and educators scrambling to make last minute changes to accommodate new realities of COVID 19 and public health orders.

THEREFORE BE IT RESOLVED that the Legislative Assembly of Manitoba urge the Provincial Government to immediately invest in provincial public schools to hire more teachers, hire more educational assistants, acquire new spaces for teaching and programming, provide more mental health supports for students and educators, invest in remote learning supports and use the money provided by the Federal Government to ensure all Manitoba students receive the education they deserve.

By leave, Hon. Mr. PALLISTER, the Honourable First Minister, made a statement regarding Veterans' Week.

Mr. KINEW and, by leave, Ms. LAMOUREUX commented on the statement.

By leave, Hon. Mrs. Cox, the Minister of Sport, Culture and Heritage, made a statement recognizing Diwali.

Mr. BRAR commented on the statement.

Pursuant to Rule 27(1), Messrs. SMITH (Lagimodière) and WIEBE, Ms. MARCELINO, Messrs. LAMONT and REYES made Members' Statements.

Following Oral Questions, Madam Speaker made the following ruling:

On March 12, 2020, the Honourable Member for Wolseley rose on a Matter of Privilege regarding the Government's failure to present a report on the Government's Climate and Green plan. She expressed her opinion that this failure to provide information as required by legislation misled the House and breached her privileges as a legislator. The Member concluded her remarks by moving: "*THAT this issue be moved to an all party committee for consideration*."

The Honourable Member for River Heights and the Honourable Government House Leader also spoke to the Matter of Privilege before I took it under advisement. I thank all Members for their advice to the Chair on this matter.

For the information of all Members, in order for the matter raised to be ruled in order as a *prima facie* case of privilege, Members must demonstrate both that the issue has been raised at the earliest opportunity, and also provide sufficient evidence that the privileges of the House or the privileges of individual Members have been breached.

Regarding timeliness, the Honourable Member for Wolseley asserted that she was rising at the earliest opportunity on this issue after providing an adequate amount of time since the start of session for the Minister to table the Government's Climate and Green Plan annual report before the House. In reviewing the statutory provisions pertaining to the report in question, it appears that the Honourable Member for Wolseley may have raised this matter prematurely as the deadline for the tabling of the report had not yet passed at the time the Matter of Privilege was raised. As a result, it is difficult to rule that this matter met the true test of timeliness simply because the Member indicated that she raised the matter at the earliest opportunity without providing mitigating circumstances.

Regarding the second condition of whether a *prima facie* case has been demonstrated, the Member argued that "the failure of the government to provide information as required by legislation misleads this House about the true state of the government's actions and, as such, breaches her privileges as a legislator". She further stated that "violating this legal obligation for public accountability obstructs her from doing her job and holding the Pallister government to account."

Based on her comment in the House on March 12, 2020, the Honourable Member for Wolseley appears to have a grievance against the Government regarding the tabling of the Government's Climate and Green Plan annual report rather than a matter of privilege.

Furthermore, I would like to quote from a ruling given by Speaker Hickes on December 7, 2004:

"I have checked the procedural authorities, and there is no reference or citation that advises that it is a matter of privilege if a government does not table information when requested to do so, with the exception of items that are required to be tabled by statute. Should the information in question sought be an item that is required by statute to be tabled, there may be some scope for privilege, as Speaker Fraser of the House of Commons ruled on April 19, 1993, that failure to table a document as required by statute was a prima facie case of privilege."

In looking at the tabling requirements for the Government's Climate and Green Plan, it indicates that the report is to be tabled within 15 days after it has been prepared if the Assembly is sitting, or if the Assembly is not sitting, within 15 days after the next sitting period begins. For this particular Matter of Privilege raised, the Speaker is not in possession of information that would verify if the report in question was in fact published or ready to be tabled in the Assembly. Therefore it is virtually impossible to know if the deadline has been missed.

I appreciate that the report in question may be an issue of concern to the Member, but I am must rule that this matter does not constitute a *prima facie* case of privilege.
