PRAYER AND LAND ACKNOWLEDGEMENT

10:00 O'CLOCK A.M.

Immediately following the Prayer and Land Acknowledgement, Mr. KHAN rose on a matter of privilege alleging that comments made by the First Minister during Oral Questions on October 1, 2025, were defamatory and impeded his ability to ask questions, and moved:

THAT the Member for Fort Rouge be compelled to retract their remarks, apologize, and the matter be referred to the Standing Committee on the Legislative Affairs for further consideration.

And Hon. Mr. WIEBE having spoken.

The House resumed the debate on the proposed motion of Mr. JOHNSON:

The House resumed the debate on the proposed resolution of Mrs. COOK:

Resolution No. 13: School Tax and Education Property Tax Increases

WHEREAS the current Provincial Government has allowed out-of-control, double-digit school tax increases across Winnipeg and Manitoba, pushing property tax bills to unsustainable levels for homeowners, seniors, workers, and families; and

WHEREAS the City of Winnipeg has called the Provincial Government's property tax grab "historic", as residents across Winnipeg are opening property tax bills this week showing hundreds of dollars more coming out of their pockets; and

WHEREAS according to City of Winnipeg data, residents are facing school tax increases of 14% in Pembina Trails, 17% in Louis Riel, 14% in River East Transcona, and 15% in Winnipeg School Division; and

WHEREAS the Provincial Government plans to collect \$182 million more in education property taxes in Budget 2025 through tax increases and the elimination of the 50% school tax rebate; and

WHEREAS this amount is on top of the \$150 million more collected from Manitobans through education property tax increases in Budget 2024; and

WHEREAS the previous, PC Provincial Government began eliminating education property taxes by introducing a 50% rebate for all homeowners, seniors, and farmers, and reduced education property taxes on businesses by 10%; and

WHEREAS the Provincial Government has failed to introduce a new education funding formula as promised and has instead increased education property taxes on homeowners, small businesses and cottage owners; and

WHEREAS this is a direct result of the Provincial Government eliminating the PCs' universal 50% school tax rebate and replacing it with a limited tax credit that applies only to primary residences—leaving cottagers, small businesses, and others having to pay more; and

WHEREAS Manitoba seniors on fixed incomes should not be taxed out of their homes due to reckless decisions made by the Finance Minister; and

WHEREAS the Provincial Government must stop punishing working families with exorbitant school tax hikes, especially when Manitobans are already struggling with a cost-of-living crisis; and

WHEREAS families and businesses are facing double-digit education property tax increases across the province.

THEREFORE BE IT RESOLVED that the Legislative Assembly of Manitoba urge the Provincial Government to stop these harmful tax hikes and eliminate school taxes from properties in Manitoba.

The following Bill was read a First Time and had its purposes outlined:

(No. 48) – The Protective Detention and Care of Intoxicated Persons Act/Loi sur la détention des personnes agissant sous l'influence d'une substance intoxicante aux fins de protection et de prestation de soins

(Hon. Ms. SMITH)

Hon. Min. FONTAINE, the Minister of Families, made a statement regarding October 4, 2025, being Missing and Murdered Indigenous Women and Girls Honouring and Awareness Day.

Ms. BYRAM commented on the statement.

Pursuant to sub-rule 28(1), Hon. Min. FONTAINE, MLAs BEREZA and CROSS, Mr. BALCAEN and Hon. Min. SCHMIDT made Member's statements.

The following petitions were presented and read to the Legislative Assembly of Manitoba:

Mr. BALCAEN – To urge the Provincial Government to remove the federal carbon tax on home heating bills for all Manitobans to provide them much needed relief.

Mrs. Stone – To urge the Government of Manitoba to immediately work with the Prairie Rose School Division to begin the process of replacing the gymnasium facilities at the Elm Creek School, in consultation with parents and the community.

Ms. BYRAM – To urge the Provincial Government to immediately work with the RCMP to restore rural community policing and provide adequate resources to protect Manitoba communities.

Mr. JOHNSON – To urge the Provincial Government to cancel drug-injection sites in the Point Douglas community, including the proposed location at 200 Disraeli Freeway; and to legislate that no future site will be proposed without community support.

Mr. Khan – To urge the Provincial Government to take immediate and decisive action on bail reform to address serious deficits in enforcement by utilizing all available provincial mechanisms to strengthen warrant enforcement, increasing bail supervision, and opposing release of offenders, thus ensuring that repeat violent offenders are held accountable and that public safety is prioritized over leniency; and to lobby the Federal Government to immediately repeal provisions of the Criminal Code that allow for the continued victimization of law-abiding Manitobans while granting repeat offenders additional rights.

MLA BEREZA – To urge the Provincial Government to cancel drug-injection sites in the Point Douglas community, including the proposed location at 200 Disraeli Freeway; and to legislate that no future site will be proposed without community support.

Mr. EWASKO – To urge the Provincial Government to take immediate and decisive action on bail reform to address serious deficits in enforcement by utilizing all available provincial mechanisms to strengthen warrant enforcement, increasing bail supervision, and opposing release of offenders, thus ensuring that repeat violent offenders are held accountable and that public safety is prioritized over leniency; and to lobby the Federal Government to immediately repeal provisions of the Criminal Code that allow for the continued victimization of law-abiding Manitobans while granting repeat offenders additional rights.

Mr. GOERTZEN – To urge the Provincial Government to take immediate and decisive action on bail reform to address serious deficits in enforcement by utilizing all available provincial mechanisms to strengthen warrant enforcement, increasing bail supervision, and opposing release of offenders, thus ensuring that repeat violent offenders are held accountable and that public safety is prioritized over leniency; and to lobby the Federal Government to immediately repeal provisions of the Criminal Code that allow for the continued victimization of law-abiding Manitobans while granting repeat offenders additional rights.

Mr. GUENTER – To urge the Provincial Government to support Manitoba small businesses through specific funding to reimburse the expenses and insurance deductibles that they incur as a result of crime.

Mr. KING – To urge the Provincial Government to take immediate and decisive action on bail reform to address serious deficits in enforcement by utilizing all available provincial mechanisms to strengthen warrant enforcement, increasing bail supervision, and opposing release of offenders, thus ensuring that repeat violent offenders are held accountable and that public safety is prioritized over leniency; and to lobby the Federal Government to immediately repeal provisions of the Criminal Code that allow for the continued victimization of law-abiding Manitobans while granting repeat offenders additional rights.

MLA LAGASSÉ – To urge the Provincial Government to order an out-of-province review of the prosecutor's decision to not prosecute the accomplice in the death of Jordyn Reimer.

Mr. NARTH – To urge the Minister of Education and Early Childhood Learning to immediately bring back the three portable classrooms to help alleviate the stress and overcrowding classrooms; and to urge the Provincial Government to reinstate the expansion project for Green Valley School.

Mr. NESBITT – To urge the Minister of Transportation and Infrastructure to take the necessary steps to upgrade Provincial Trunk Highway 45 from Russell to Provincial Trunk Highway 10 to meet RTAC standards.
