ADJOURNED DEBATE (THIRD DAY OF DEBATE):

On the Proposed Motion of Hon. Mr. SELINGER -

THAT this House approve in general the budgetary policy of the government.

And the Proposed Motion of Mr. MURRAY in amendment thereto as follows:

That the Motion be amended by deleting all the words after "House" and substituting the following words:

therefore regrets this Budget ignores the present and future needs of Manitobans by:

- (a) Failing to be accountable to Manitobans for the overspending and fiscal mismanagement of this Doer NDP government; and
- (b) Failing to be accountable for the fact that Manitoba families will be the highest taxed of any province in Canada; and
- (c) Failing to provide a long-term strategy to bolster Manitoba's economy and make Manitoba a "have" province; and
- (d) Failing to be accountable for the dismal state of agriculture in Manitoba and the lack of sufficient slaughter capacity in the province and to provide a sustainable plan for the growth of agriculture and the rural economy; and

- (e) Failing to provide a climate that encourages private sector job creation and growth in the province, to provide opportunity for Manitoba youth to remain in the province; and
- (f) Failing to accept responsibility and be accountable for the province's unprecedented level of debt, which has grown to over \$20 Billion under the Doer NDP government, thereby mortgaging our children's and grandchildren's future; and
- (g) Failing to eliminate education taxes off residential property and farmland; and
- (h) Failing to provide adequate funding for post secondary institutions; and
- (i) Failing to be accountable for the dead last ranking of Manitoba's health care system by the Conference Board of Canada; and
- (j) Failing to be transparent and accountable for where health care dollars are being spent; and
- (k) Failing to be accountable for the increased court backlog and probation breaches; and
- (l) Failing to provide a long term strategy for the revitalization of rural Manitoba and continuing to ignore rural Manitobans; and
- (m) Failing to be accountable for drawing money from the "rainy day fund" in times of unprecedented revenues.

As a consequence, the Government has thereby lost the confidence of this House and the people of Manitoba.

1. Will the Minister of Education, Citizenship and Youth strike a COLA advisory committee to review the COLA issue and to make recommendations to him on reaching a sustainable solution?

- 2. Will the Minister of Education, Citizenship and Youth ensure that thorough and full actuarial modeling is carried out related to the teachers' pension plan and COLA and that this information be provided to the COLA advisory committee to assist them in making their recommendations?
- 3. Can the Minister of Education, Citizenship and Youth tell us if all schools in Manitoba now have a finalized code of conduct in place that addresses bullying?
- 4. Can the Minister of Education, Citizenship and Youth tell us if there is consistency in all of the codes of conduct regarding experiences and consequences of bullying?
- 5. Can the Minister of Education, Citizenship and Youth tell Manitoba why he refused, on three separate occasions, to provide the Opposition with copies of these codes of conduct? Why did he refuse to share this information about how schools are addressing bullying?
- 6. Has the Minister of Education, Citizenship and Youth investigated the excessive violence reported at the R. B. Parker Collegiate in Thompson?
- 7. Is the Minister of Education, Citizenship and Youth giving more than lip services to his Safe Schools legislation?
- 8. Why is the Minister of Education, Citizenship and Youth refusing to fund the Director of Safe Schools Manitoba at a full-time position and why are there no support staff and administrative staff available to Dr. May Hall from the Department of Education?
- 9. What is the Minister of Education, Citizenship and Youth doing to address the crisis situation in the Leaf Rapids Education Centre?
- 10. Will the Doer Government commit to eliminating, in Manitoba their aggressive ad campaigns urging people to gamble? Why are they promoting something they so stridently objected to when they were in Opposition?
- 11. Will the Doer Government follow through with their commitment to fully fund the requirements of Bill (No. 13)?
- 12. What is the Minister of Education, Citizenship and Youth doing to address concerns that there is an identified need for enhanced pre-service training and on-going professional development for practicing teachers in the area of student assessment?
- 13. What is the Minister of Education, Citizenship and Youth doing to address concerns that increased resources are needed in the areas of language training and social services for immigrant and refugee students and their families to ease the transition and integration of newcomers to Manitoba's diverse cultural mosaic?
- 14. What is the Minister of Education, Citizenship and Youth doing to improve Manitoba's high school graduation rates?

- 15. When will the Doer Government address the education funding mess in this province and remove education funding from property taxes?
- 16. As the Critic for the Status of Women I'm asking, on behalf of Manitoba women, why the Doer Government is supporting the elimination of the clinical breast-exam service at the Manitoba Breast Screening Program?
- 17. Can the Minister responsible for the Status of Women confirm that this was a cost-cutting measure?
- 18. Can the Minister responsible for the Status of Women explain why five part-time nurses and a part-time technologist were laid off at the Manitoba Breast Screening Program?
- 19. Can the Minister responsible for the Status of Women tell us if the Manitoba Breast Screening Program is under funded?
- 20. Can the Minister responsible for the Status of Women tell us whether she fought, at the cabinet table, against the breast exam cuts at the Manitoba Breast Screening Program? Did she stand up for Manitoba women?
