ORAL QUESTION PERIOD

MR. SPEAKER: The Honourable Member for Riel.

MR. DONALD W. CRAIK (Riel): Mr. Speaker, I would like to direct a question to the House Leader. Can he indicate when the Public Utilities Committee will meet again this Session?

MR. SPEAKER: The Honourable House Leader.

HON. SIDNEY GREEN, Q.C. (Minister of Mines, Resources and Environmental Management) (Inkster): Mr. Speaker, no, and I can't indicate that they will. I think that that's been made explicitly clear in previous questions, that they may meet before the Session is over, they meet after the Session is over.

MR. CRAIK: Mr. Speaker, might I ask a related question to the House Leader? Is it not the intention to present the report of the last Utilities Meeting either?

MR. SPEAKER: The Honourable Member for Crescentwood.

MR. CY GONICK (Crescentwood): A question to the Minister of Labour. I wonder if he could give to the House a report on the strike at CJAY and whether or not his office has been asked to give its assistance to settling it?

MR. SPEAKER: The Honourable Minister of Labour.

HON. RUSSELL PAULLEY (Minister of Labour) (Transcona): The answer, Mr. Speaker, is that I have not been asked directly by the employees represented by CJAY to use our facilities precisely. I have on a number of occasions been requested to give some information as to how the situation would prevail if it were under provincial law. This is another one of those

(MR. PAULLEY cont'd.) incidents that unfortunately is under Federal law and the Minister of Labour of Manitoba cannot take concrete action.

MR. SPEAKER: The Honourable House Leader.

MR. GREEN: Mr. Speaker, the Law Amendments Committee has not yet completed their considerations of Bills presently referred to them and it's the intention of all honourable members, to my understanding, that we go back to Law Amendments Committee for this afternoon and that the House be called again in regular session this evening at 8 o'clock. Unless there is anything that arises from the remarks that I've just made, and there appears to be nothing, I move, seconded by the . . .

MR. SPEAKER: The Honourable Leader of the Opposition.

MR. SIDNEY SPIVAK, Q.C. (Leader of the Opposition) (River Heights): Mr. Speaker, just a request of the House Leader. I wonder if he can indicate whether in the event we finish - we are not going to come back to the House today at all - until tonight?

MR. GREEN: Mr. Speaker, we would come back to the House today at 8 o'clock to continue the deliberations. I'm sort of gambling that we won't finish in Law Amendments before 5:30, therefore we would want the House to be in session this evening because we might want to come back after Law Amendments finishes this evening.

MR. SPIVAK: Then it is not likely that we will reach Municipal Affairs this evening?

MR. GREEN: Well the schedule of business, Mr. Speaker, would be to go to Law Amendments Committee this afternoon, to go to Law Amendments Committee tonight and then when we are completed to come back in the House and deal with the House business, so therefore it is extremely unlikely that we would get to Municipal Affairs Committee.

MR. SPIVAK: I wonder then if the Honourable House Leader can indicate will it be the intention of the government to go to Municipal Affairs tomorrow morning then?

MR. GREEN: Mr. Speaker, the proceedings would be to complete the material so far as we can on the House and then go to Municipal Affairs Committee to consider clause by clause the Bill before that committee. So it could be tomorrow morning, yes.

Mr. Speaker, it's been suggested to me that we may finish in Law Amendments Committee earlier this afternoon; therefore if you would just again informally leave the Chair, we could come back and adjourn the House if necessary at 5:30.

MR. SPEAKER: Thank you. In that case, I shall vacate the Chair and return at the will of the Assembly.
