**MADAM CHAIRMAN:** Seeing as how we have a quorum, I will call the Committee on Industrial Relations to order. We haven't had any indication that there are any delegations to make presentations on the three bills we have before us, Bills 75, 76, and 77. How does the committee wish to proceed?

#### BILL NO. 75 - AN ACT TO AMEND THE PAYMENT OF WAGES ACT AND OTHER ACTS OF THE LEGISLATURE; LOI MODIFIANT LA LOI SUR LE PAIEMENT DES SALAIRES ET D'AUTRES LOIS DE LA LÉGISLATURE

**MADAM CHAIRMAN:** The first one is Bill 75, An Act to amend The Payment of Wages Act. How does the committee wish to proceed, page-by-page?

MR. R. BANMAN: Page-by-page.

MADAM CHAIRMAN: Page 1—pass? Mr. Mercier.

**MR. G. MERCIER:** Madam Chairman, I wonder if the Minister of Labour could indicate whether he is proposing any amendments to the bill. I raised a matter the other day, in speaking to this on Friday.

MADAM CHAIRMAN: Mr. Minister.

**HON. A. MACKLING:** Madam Chairperson, I asked staff, Friday, to look at that and while I don't have a written report from them, they're indicating that they believe they can do it by policy direction, and by getting agreement signed by the corporate directors. The concern is that you may have one director who pays the money in, another one doesn't, and then if there's any dispute as to the liability of the directors as between themselves, then if the time has run and the director may have been fully responsible hasn't paid in, there's a problem.

What we can do is cover it by letter from, in this case - the case that the honourable member referred to me was one in which a lawyer apparently was acting for a number of directors. If there had been the directive which I now will make with the department, the department could have taken a letter from the lawyer indicating that the directors had agreed that they would pay this in, and this would be in recognition of their joint and several liability.

The way the act had been interpreted required the department to take payment from each one of the directors, but it is open, I think, to the director under The Payment of Wages Act, the director I'm referring to there, to accept payment totalling the entire wages, providing there's an agreement with the corporate director of the firm involved that that represents all of them, that money. So they're indicating that an amendment to the act, per se, may not be necessary at all, providing they have that from the directors.

MADAM CHAIRMAN: Page 1 to 8, inclusive, were each read and passed; Preamble—pass; Title—pass. Bill be reported.

#### BILL NO. 76 - AN ACT TO AMEND THE PENSION BENEFITS ACT; LOI MODIFIANT LA LOI SUR LA PENSION DE RETRAITE
