



# MANITOBA TRADE UPDATE

## THIRD QUARTER, 2024

### Manitoba Exports

Manitoba exported \$15,232.2 million worth of merchandise to the rest of the world from January to September of 2024. This was \$659 million (-4.1%) less than the \$15,890.9 million exported during the same period in 2023.

Manitoba's exports to the United States (U.S.), which account for 72.9% of all exports, decreased by \$617 million (-5.3%). Meanwhile, exports to China, Manitoba's second-largest trading partner with a share of 7.3%, increased by \$29 million (+2.7%). Manitoba's exports to the third largest trading partner, Japan, rose \$58 million (+9.7%).

Almost half of all U.S. exports went to Midwestern states, decreasing by 1.2% on a year-to-date basis to \$5,369.9 million. One-fifth of U.S. exports went to Southwestern states, a decrease of \$717 million (-23.5%) over the same period, mostly due to a decline in pharmaceutical-related exports to Tennessee. Exports to Eastern states had the largest year-to-date increase, rising by \$78 million (+8.3%).

Agriculture exports decreased by \$315 million (-17.4%) due to a reduction in crop prices compared to last year. This included a decrease in wheat exports by \$148 million (-11.4%) and rape or colza seeds (whether or not broken) by \$116 million (-14.9%). Offsetting this were exports of soya beans (whether or not broken), which increased by \$46 million (+20.2%).

Manufactured product exports fell by \$370 million (-3.4%). The largest valued commodities contributing to this sector included: 1) Packaged medicines in specific doses for retail, down \$607 million (-32.4%), as the U.S. purchased less from Manitoba; 2) Pork, fresh, chilled, or frozen, up \$159 million (+17.6%) due to increased demand from Japan; 3) Unmodified canola, colza, or mustard oil and their parts, down \$214 million (-20.5%) as the export value to the U.S. fell due to a decrease in price.

### Manitoba Imports

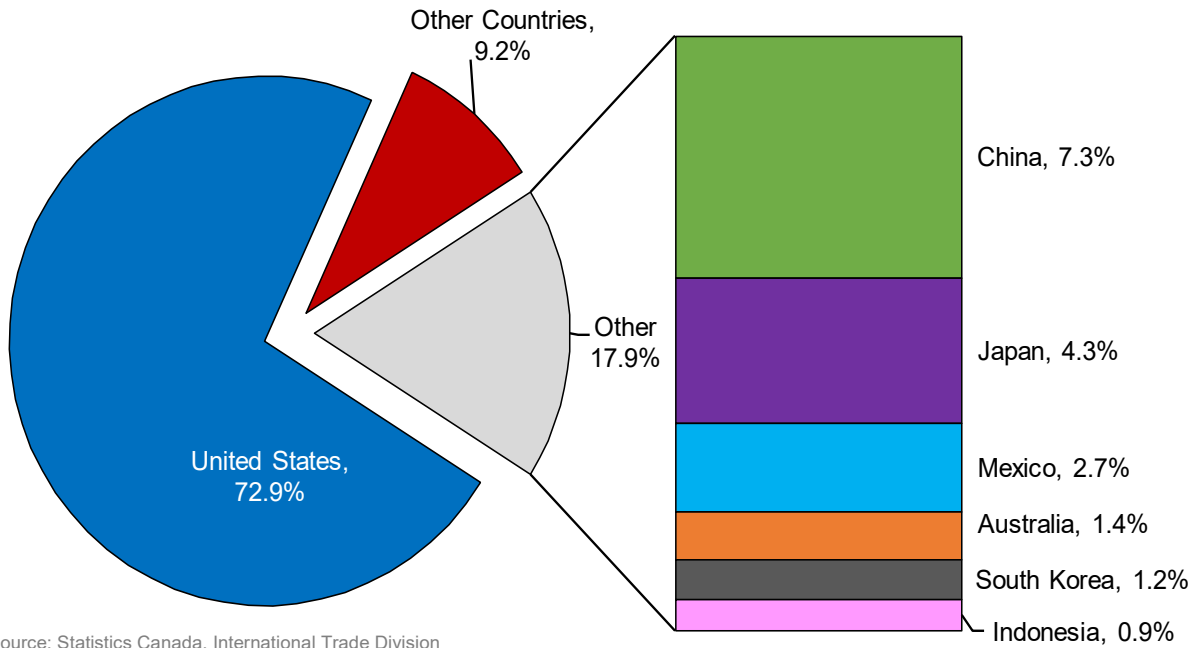
Manitoba's imports were valued at \$23,485.4 million worth of merchandise from the rest of the world from January to September of 2024, up \$309 million, or 1.3% more than was imported in the same period last year.

Nearly 75% of Manitoba's internationally imported goods come from the U.S., up \$124 million (+0.7%) on a year-to-date basis. China is Manitoba's second-largest trading partner, accounting for 5.4% of imports, which fell by \$45 million (-3.4%). Mexico, Manitoba's third largest trading partner, saw the value of imported goods increase by \$142 million (+13.8%).

Manitoba's imports of manufacturing products grew by \$381 million (+1.8%) on a year-to-date basis ending in September 2024. Over 90% of all international imports into Manitoba are manufacturing-related. Key commodities contributing to Manitoba's imports included: 1) Turbo-jets, turbo-propellers and other gas turbines, up \$169 million (+19.9%); 2) Harvesting, threshing, and other agricultural and mowing machinery, up \$69 million (+7.8%); 3) Tractors, up \$51 million (+6.5%); 4) Fertilizers, up \$22 million (+3.5%).

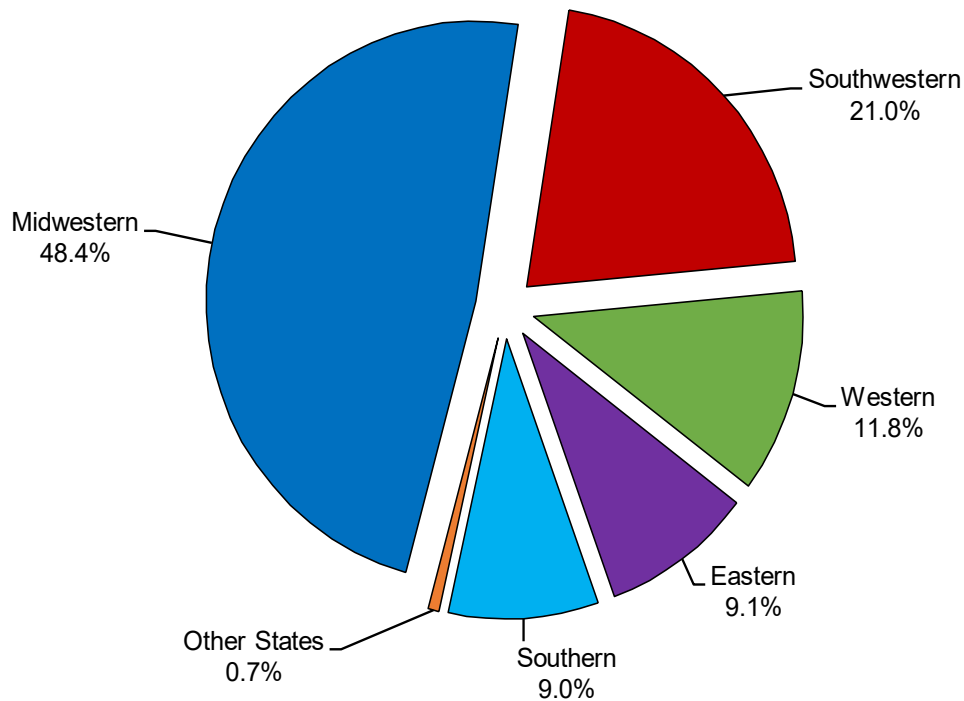
## Manitoba exports by selected countries, share (%)

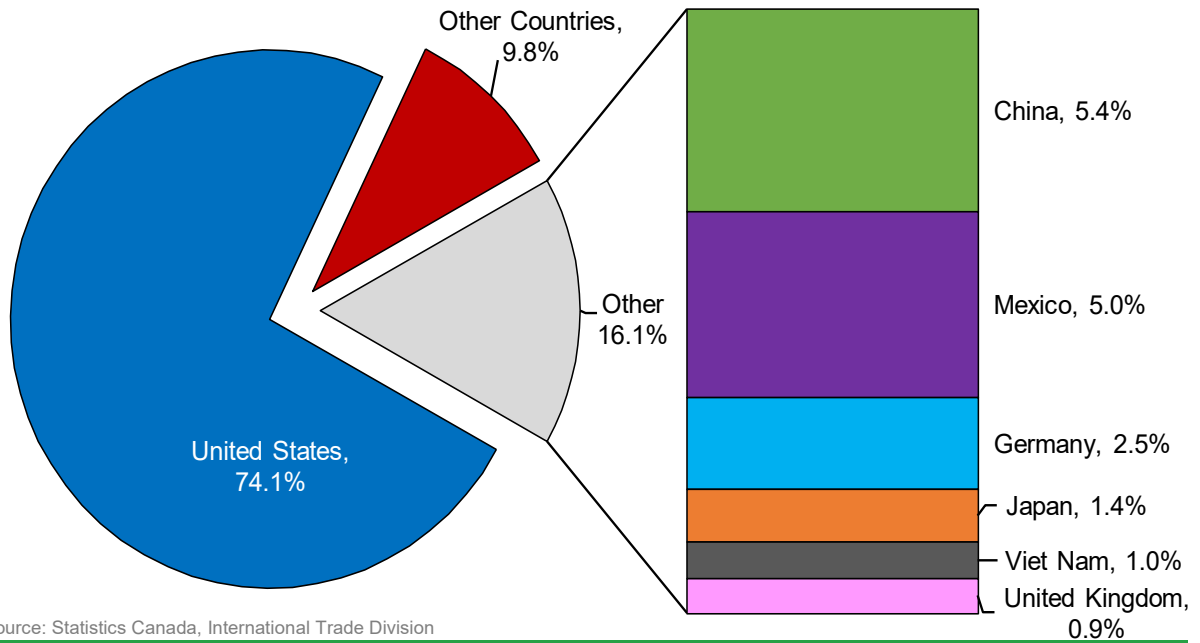

## Manitoba imports by selected countries, share (%)

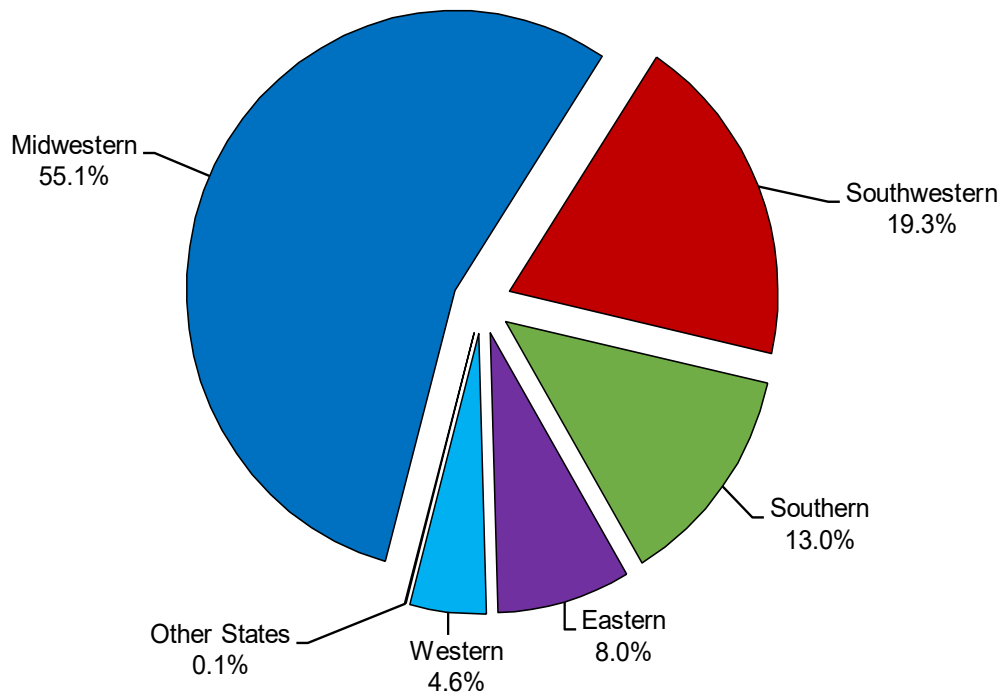
January to September 2024

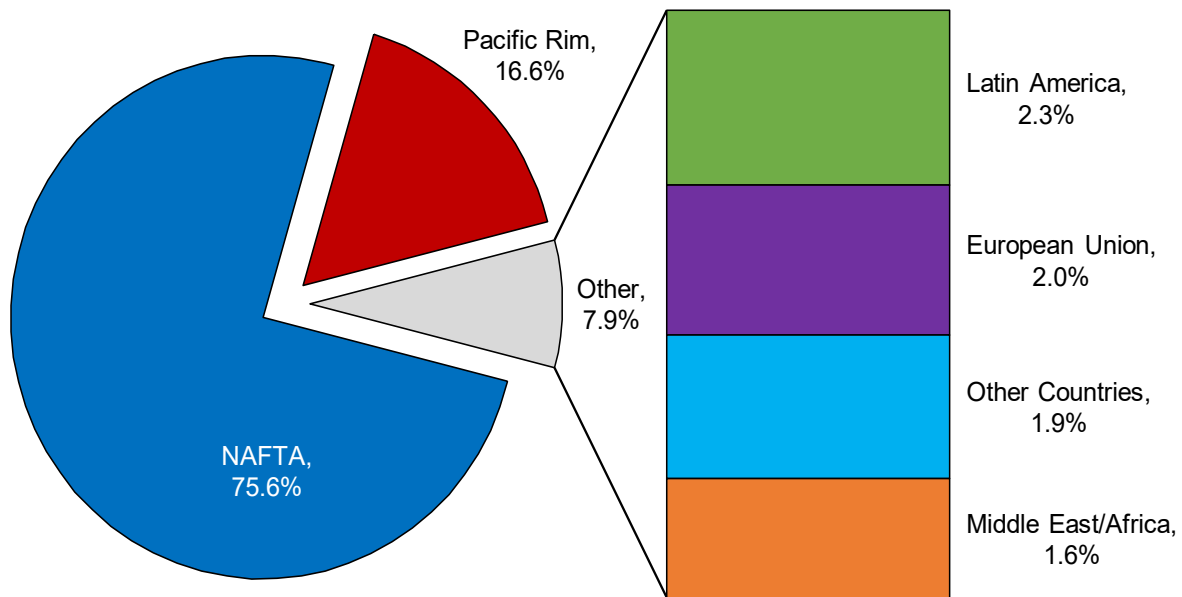

## Manitoba exports by country grouping, share (%)

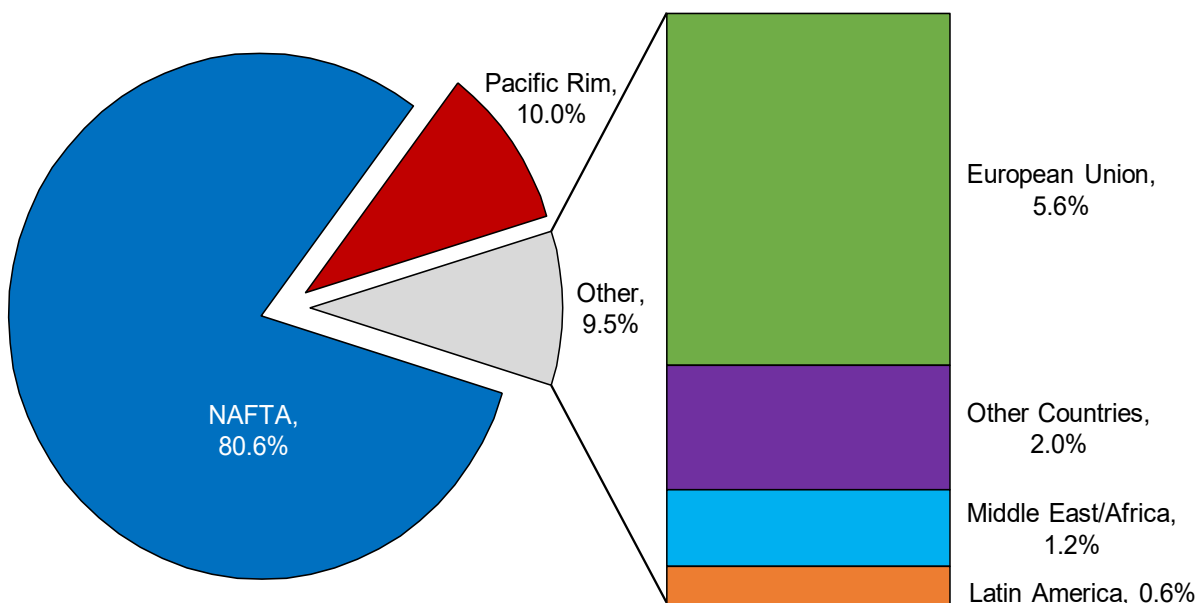
January to September 2024

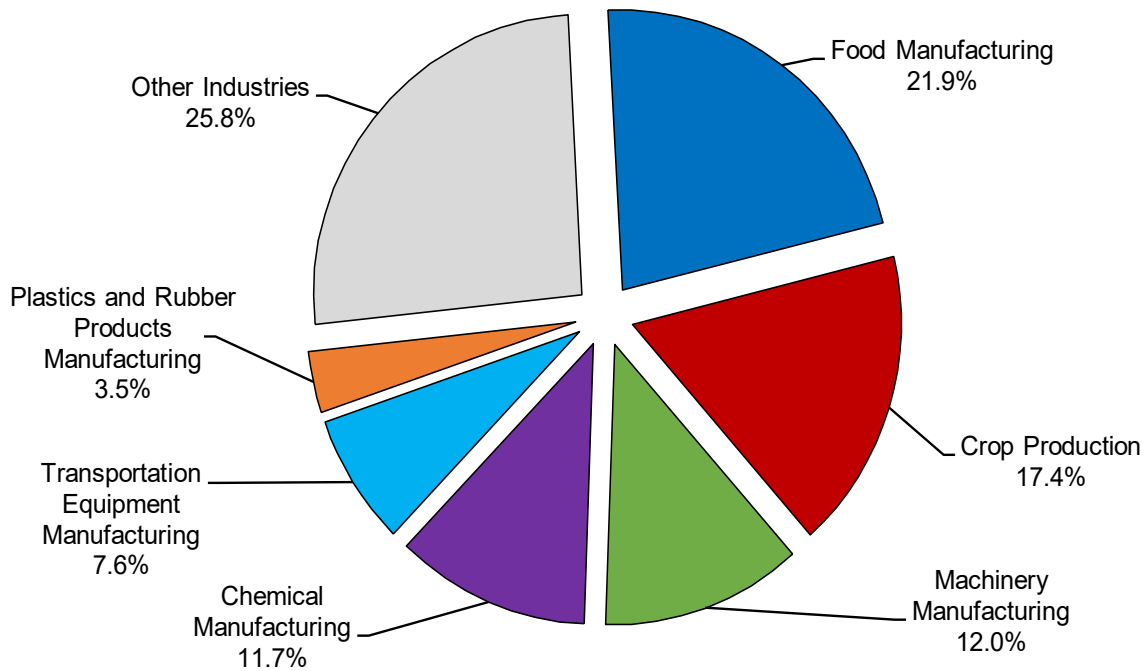

## Manitoba exports by industry, share (%)

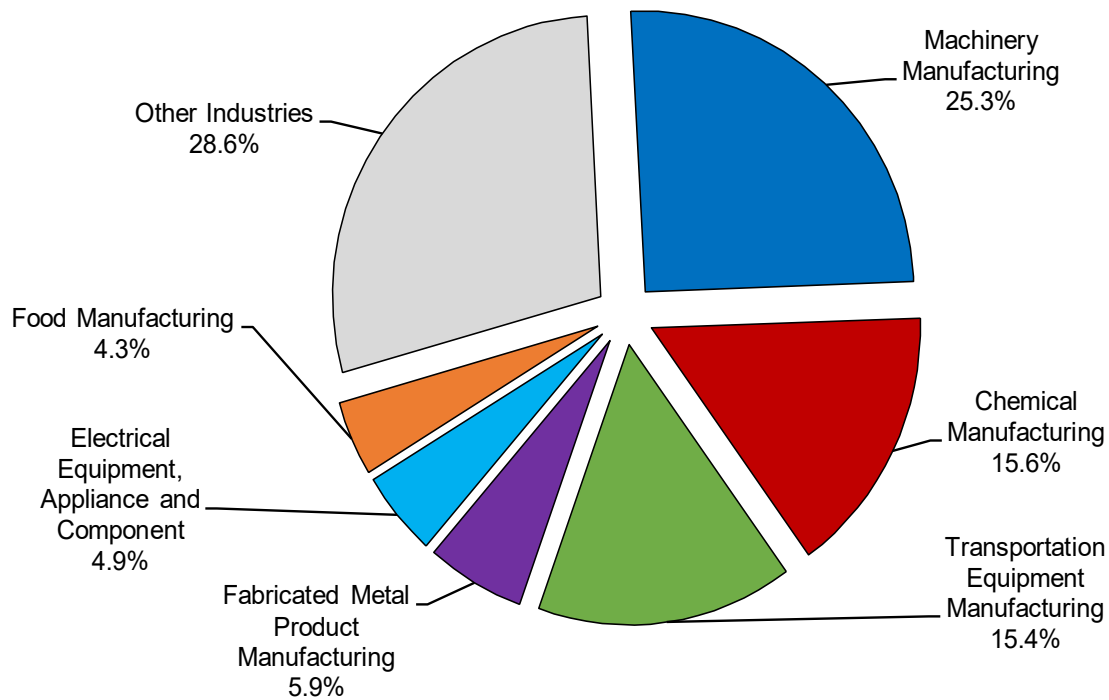
January to September 2024

## Note to Readers

The Manitoba Bureau of Statistics (MBS) has prepared this report as part of its economic statistics program. The purpose is to provide Manitoba-level information on the importance and impact of international merchandise trade.

This publication provides merchandise export and import statistics by country, country grouping, commodity and industry. The information is from Statistics Canada's International Trade Division.

MBS adjusts the value of exports for some commodities in its Manitoba Economic Accounts. These adjustments are undertaken to better reflect the value of the foreign export of these commodities to the provincial economy.

Users should be aware that the export data is on a "province of origin" basis, while the import data is on a "province of clearance" basis. Therefore, imports from other countries are not counted if they are cleared through custom ports in other provinces and then shipped to Manitoba (MBS would count these as interprovincial imports). This implies that the trade balances calculated for individual countries could overstate Manitoba's actual position.

As part of the 2022 World Customs Organization (WCO) amendments, a number of codes have been terminated and recoded. Updates at the 6-digit level are made every 5 years by the WCO, in order to reflect new international standards and trade patterns. While all commodity data presented in this report are based on the 4-digit level Harmonized System (HS) codes, the information presented may be affected by these changes.

All industry data presented in this report are based on the North American Industry Classification System (NAICS) and are derived from HS code values. The concordance file used in converting the commodity data into industry values is derived from Statistics Canada. With the emergence of HS 2022 codes, revisions to this concordance file have since been maintained by MBS. As a result, there may be discrepancies in the industry details within this report when compared to other industry-based data sources.

MBS can provide additional detailed export/import information to users upon request, which includes:

- i) individual commodities for specific countries.
- ii) individual commodities by country (volume and dollar value) at the 4, 6, 8, or 10 digit HS level.
- iii) commodities by country for specific industries or sectors.

The data presented in this report has been derived from the most current estimates released by Statistics Canada's International Trade Division. Revisions for 2023 calendar year have been incorporated in this report.
