### ISSUED PURSUANT TO SUBSECTION 68(3.3) OF THE HIGHWAY TRAFFIC ACT (C.C.S.M. c. H60)

# RESPECTING PERMISSIBLE VEHICLE LENGTH AND OTHER PERMISSIBLE LONGITUDINAL CHARACTERISTICS ON HIGHWAYS FOR WHICH THE MINISTER OF INFRASTRUCTURE IS THE TRAFFIC AUTHORITY

Pursuant to the authority vested in me under subsection 68(3.3) of *The Highway Traffic Act*, I order that:

"fifth wheel recreational trailer" means a vehicle without motive power

- (a) with no less than two-thirds of its overall length designed for use as temporary living quarters, and
- (b) designed so that a substantial part of its weight and load rests on and is carried by the truck to which it is attached by a fifth wheel coupler.
- 1. Despite subsection 13(1) of the *Vehicle Weights and Dimensions on Classes of Highways Regulation*, M.R. 155/2018, the following restrictions shall apply to all highways in the Province of Manitoba for which I am the traffic authority:

A person must not drive or operate on a highway

- (a) a truck in combination with a fifth wheel recreational trailer if
  - (i) their combined overall length is longer than 21.5 m., or
  - (ii) the overall length of the fifth wheel recreational trailer is longer than 14.65 m.
- 2. This Order is in effect until 4:00 p.m. on June 15, 2022.
